

Transfer Credit for Sask Polytechnic Business Programs

The University of Regina's Hill School of Business has a formal transfer credit agreement with Sask Polytechnic for their graduates from the following programs:

- Business Diploma in Accountancy
- Business Diploma in Financial Services
- Business Diploma in Human Resources
- Business Diploma in Insurance

- Business Diploma in Management
- Business Diploma in Marketing
- **Business Certificate**

Things to know

- A SaskPoly program GPA of at least 65% is required for admission to the Paul J. Hill School of Business
- Transfer credit is subject to change, and evaluation is completed on a course-by-course basis upon admission
- This transfer credit agreement applies only to programs completed at Saskatchewan Polytechnic locations within Canada





How it works

Graduates of the approved programs will receive University of Regina transfer credit for up to 30 credit hours in the case of a completed Business Certificate Program and up to 60 credit hours for a completed Business Diploma Program.

A grade of 60% or higher in each course is required to be considered for transfer credit.
