\* Master of Public Policy and Johnson-Shoyama PhD students must register full time (six credit hours) in each semester, are considered full time and are assessed a flat tuition fee regardless of how many credit hours they are registered in.

**JSGS 850 AA - ZZ** For students registered in Johnson-Shoyama internship courses. Tuition will be assessed at \$1,217.50 plus Mandatory Student Fees (based upon 6 credit hours) according to the schedule above plus the International Surcharge if applicable.

~ URSU fees will be assessed as \$39.35/student plus \$5.00/credit hour. All students on campus and off campus, including Federated College students, are required to pay the Student's Union Fee. Student's Union Fees will not be assessed on off-campus contract classes.

\*\* Student Health and Dental Plan - For the Winter 2022 semester, students who did not take classes in the Fall 2021 semester are eligible to opt into the URSU Health and Dental Plan. The fee for coverage from January 1, 2022 to August 31, 2022 is \$145.45 (\$65.32 for Health and \$80.13 for Dental). Students first beginning classes in the winter semester can opt-in to the Plan from January 5, 2022 until February 1, 2022 by going directly to [www.mystudentplan.ca](http://www.mystudentplan.ca). Once the student has opted into the plan, **premiums for the plan are non-refundable even if a student drops out of University**. The student will continue to be eligible for benefits until the new plan year. Full Plan details are available on URSU's website at: <https://ursu.ca/services/health-dental-plan/>.

\*\*\*Academic Technologies Fee of \$22.25 per semester will be assessed to all students on campus and off campus (including Federated College students). The Academic Technologies Fee will not be assessed for on campus or off campus contract classes.

^ All full-time and part-time students enrolled in at least one on-campus course will be assessed an additional \$87.60 U-Pass Fee. The fee is collected by the University on behalf of URSU and remitted to URSU for the purpose of providing subsidized transit services as per the terms of the U-Pass Agreement established between URSU and the City of Regina. U-Pass and the \$87.60 fee are mandatory but students can opt-out if they meet the opt-out criteria and have not already loaded their U-Pass. The opt-out period is from January 5, 2022 to February 1, 2022.
