Duties:

The role of the Investment and Infrastructure Committee is to provide oversight and make recommendations to the Board of Governors on matters regarding the University's physical and financial infrastructure, and activities (research, fundraising, ancillary services) that support the University's growth. The Investment and Infrastructure Committee also approves targets and monitors progress on the University's Performance Measurement Framework

Physical Infrastructure

- 1. Approval and oversight of major capital projects, including submissions for government funding,
- 2. Oversight of the University's preventative maintenance and renewal programme, and approval of significant projects, including submissions for government funding.
- 3. Receive and review on an established schedule reports regarding capital, preventative maintenance and renewal, fundraising, research revenue and ancillary services in relation to the established budget and work plan.
- 4. Review and recommend to the Board approval of all land and facilities ownership transactions.
- 5. Review and recommend to the Board approval of the Campus Master Plan including revisions to it and all major capital projects (over \$500,000).
- 6. Review and recommend to the Board approval of new or changes to policies pertaining to the acquisition, operation, maintenance and use of campus physical assets.

Investment and Financing

7. Recommend to the Board approval of execution of any new long-term debt.

- 8. Review and recommend to the Board approval of investment managers and investment policies (SIP&Gs) for the University's Trust and Endowment Fund including long-term investment objectives, long-term asset mix, and the benchmark portfolio to be used to judge and monitor investment performance.
- 9. Review and recommend to the Board approval of the terms of reference for the Trust and Endowment Committee, including any changes in its membership.

Research, Fundraising and Ancillaries

- 10. Review and recommend to the Board approval of the creation and/or dissolution of research institutes and centres or corporate entities as recommended by management.
- 11. Regularly review reports on fundraising activities and initiatives.
- 12. Review and recommend to the Board approval of changes in ancillaries fees and prices.
- 13. Review and recommend to the Board approval of changes to the parking bylaws.
- 14. Review and recommend to the Board approval of new or changes to policies pertaining to ancillaries, research and fundraising.

15. Review and recommend to the Board approval of the University's Performance Measurement Framework. Receive and review for information periodic reports on the Performance Measurement Framework
