
# What is the Health Research Data Platform-SK?

- The Health Research Data Platform Saskatchewan (HRDP-SK) is Saskatchewan's first integrated health data platform that integrates health data into a secure data environment and provides data access to researchers in a privacy protective manner.
- HRDP-SK aligns Saskatchewan with the other provinces which all have similar data access centers.

# Data Collection

Data are collected in normal health system activities (e.g. patient records)

## Research Process

Researchers may seek to use this data to answer research questions

## Dissemination

The results they find can be used to inform health care decisions and inform the public.

...know how many people were discharged from Saskatchewan hospitals last year? ...know how many people saw their physician for a physical last year?

...estimate changes in disease prevalence in Regina over time?

- Was born in 2010
- Had chicken pox in 2015
- Is on amoxicillin for strep throat

Meet Joe. He...

- Was born in 1944
- Has been taking a statin for high cholesterol since 2011
- Had a hip replacement due to osteoarthritis in 2014

## Sarah, here. She...

- Graduated medical school in 2007 and is a cardiologist
- Had a daughter via caesarean section in 2001
- Has Type I diabetes and is insulin dependant
- Spent 2 weeks in the NICU in 1984






- Saskatchewan is home to




# **HRDP-SK**

- The HRDP-SK has 7 partners






HRDP-SK Overview


# Health Research Data Network Canada

The **Data Access Support Hub (DASH)** is a one-stop data access service portal for researchers requiring multi-regional health and health-related administrative data in Canada. DASH streamlines the data access process through its centralized data access request (DAR) form and harmonizes processes to request data from multiple data repositories across the country.

## Data Access Request Process



## **Feasibility & Resource Check**

Initial review of project, letter provided for grant applications.

#### **Assessment & Authorization**

Identify data needed, create analysis plan and variable list. Ethics and Trustee Approval.

#### **Onboard & Account Request**

Users complete Privacy training. HRDP-SK assesses safety of user and approves account creation.

#### Access & Analyze Data

Data is linked and extracted based on the approved variable list and analysis plan. Data is put in secure environment and researcher conducts analysis.

## Data Access Request Process



### Vetting

Researcher requests permission to have outputs of their research transferred out of the secure research environment. HRDP-SK conducts analysis to ensure compliance with safe data use.

#### **Notice of Dissemination**

Trustees are advised by the research team of outcomes of research that will be published, presented or shared.

#### **Project Closures**

User access to data is closed. Project files are archived. Knowledge translation products are posted on HRDP-SK website.
