REVISED POLICY – Research and Scholarly Misconduct (K. McNutt)

The Research and Scholarly Misconduct policy is a governance policy that is from the Vice-President (Research) to the Board. The VPR is sharing this document for feedback from the CCR Committee. Feedback can be sent to VPResearch@uregina.ca

The current process does not give the accused sufficient amount of time to respond to the allegations before launching a formal investigation or an appeal process.

New process will allow for the accused to provide a written response within 7 days and the VPR can decide from the response if mediation is a possible approach or if a formal investigation is necessary.

Committee members agreed that a process is needed to protect the researcher and the student. This policy can remain on the agenda for September 2021 for more discussion.
