

TD Bank Group Indigenous Bursary Application Form

The TD Bank Group Indigenous Bursary was established to provide immediate assistance to Indigenous students whose continued education at the University of Regina is at risk due to unexpected financial pressures. This bursary will encourage and support Indigenous students pursuing a Bachelor degree in any Faculty or Department, who are in good academic standing and have demonstrated unexpected financial pressure.

This bursary will be awarded to University of Regina Indigenous undergraduate students who meet the following criteria:

- Pursuing an undergraduate degree in any faculty
- Self-declared Indigenous student
- In good academic standing; achieved either a minimum UGPA of 60% or a minimum if TGPA of 60% in the previous semester of full time studies; students in their first semester of study are considered in good academic standing
- Registered in a minimum of 9 credit hours in the semester the bursary is awarded
- Demonstrated financial need based on unexpected financial pressures which jeopardize the student's continued education at the University of Regina. Types of expenses may include, but are not limited to:
 - Laptops, computer training, transportation (ie: bus passes), food, clothing, rent, child care, etc

Note: students are expected to access emergency bursary programs offered through their faculty or Federated College, if available, prior to applying for assistance through this program.

The bursary will be evaluated on a case-by-case basis, with priority given to emergency expenses and demonstrated need.

A variable number of bursaries are available (to a maximum of \$1,000 each) to be distributed throughout the academic year as applications are received and as funds are available.
