EMBA students New students entering the program are assessed a program fee of \$56,835 over 3 semesters. Full-time mandatory student fees are assessed each semester. Current EMBA students will pay the program fee in effect when they entered the program as well as full-time mandatory student fees each semester. If a class needs to be repeated by new or current students, it will be assessed tuition based upon the MBA/MHRM/M.ADMIN/M.Sc/Levene MBA/M.CERT rates above plus mandatory student fees. Program fees for new students entering future EMBA cohorts are subject to change without notice.

GBUS/MBBA 801, 802 and 803 are for Business students in co-op work placement courses. Co-op fee will be assessed at \$1,149.00 for the term

*Students' fees will be assessed as \$44.60/student plus \$5.70/credit hour. All students on campus and off campus, including Federated College students, are required to pay the Students' Fee. Students' Fees will not be assessed on off-campus contract classes.

** Student Health and Dental Plan - For the Fall 2026 (202630) semester, graduate students enrolled in 6 or more credit hours (including First Nations University of Canada students) (excluding off-campus contract classes) are assessed an additional \$225.85 Health & Dental fee. The fee is collected by the University for the purpose of paying the Plan premium (\$101.15 for health coverage and \$124.70 for dental coverage). The fee is only assessed in the fall semester for health and dental coverage for 12 months beginning September 1. The Plan and the \$225.85 fee are mandatory. Students can opt-out of the health and/or dental coverage from August 1, 2026, until September 15, 2026, you must provide proof that they already have comparative alternative health and/or dental coverage. ***Academic Technologies Fee of \$26.80 per semester will be assessed to all students on campus and off campus (including Federated College students). The Academic Technologies Fee will not be assessed for on campus or off campus contract classes.

^ All full-time and part-time students enrolled in at least one on-campus course (including Federated College students) will be assessed an additional \$90.00 U-Pass fee. The fee is collected by the University for the purpose of providing subsidized transit services. U-Pass and the \$90.00 fee are mandatory, but students can opt-out if they meet the opt-out criteria. ^^ The Student Services, Health & Wellness Fee is used to provide partial funding for student health, wellness, and service initiatives. This fee is assessed to all students on campus and off campus (including Federated College students). This fee will not be assessed for on campus or off campus contract courses. This fee is mandatory even if the student does not access facilities, activities, services, and programs.
