* Master of Public Policy and Johnson-Shoyama PhD students must register full time (six credit hours) in each semester, are considered full time and are assessed a flat tuition fee regardless of how many credit hours they are registered in.

JSGS 850 AA - ZZ For students registered in Johnson-Shoyama internship courses. Tuition will be assessed at \$1,830.75 (domestic students) and \$3,497.25 (international students) plus Mandatory Student Fees (based upon 6 credit hours) according to the schedule above.

*Student fees will be assessed as \$44.60/student plus \$5.70/credit hour. All students on campus and off campus, including Federated College students, are required to pay the Students' Fee. Students' Fees will not be assessed on off-campus contract classes.

*** Student Health and Dental Plan - For the Fall 2025 (202530) semester, undergraduate students enrolled in 9 or more credit hours (including First Nations University of Canada students) (excluding off-campus contract classes) are assessed an additional \$225.85 Health & Dental fee. The fee is collected by the University for the purpose of paying the Plan premium (\$101.15 for health coverage and \$124.70 for dental coverage). The fee is only assessed in the fall semester for health and dental coverage for 12 months beginning September 1. The Plan and the \$225.85 fee are mandatory. Students can opt-out of the health and/or dental coverage **from August 1, 2025, until September 15, 2025**, you must provide proof that they already have **comparative alternative** health and/or dental coverage.

***Academic Technologies Fee of \$26.00 per semester will be assessed to all students on campus and off campus (including Federated College students). The Academic Technologies Fee will not be assessed for on campus or off campus contract classes.

^ All full-time and part-time students enrolled in at least one on-campus course (including Federated College students) will be assessed an additional \$90.00 U-Pass fee. The fee is collected by the University for the purpose of providing subsidized transit services. U-Pass and the \$90.00 fee are mandatory, but students can opt-out if they meet the opt-out criteria. The **opt-out deadline is September 15, 2025**.

^^ The Student Services, Health & Wellness Fee is used to provide partial funding for student health, wellness, and service initiatives. This fee is assessed to all students on campus and off campus (including Federated College students). This fee will not be assessed for on campus or off campus contract courses. This fee is mandatory even if the student does not access facilities, activities, services, and programs.
