EMBA students New students entering the program are assessed a program fee of \$51,850 over 3 semesters.
Full-time mandatory student fees are assessed each semester.
Current EMBA students will pay the program fee in effect when they entered the program as well as full-time mandatory student fees each semester.
If a class needs to be repeated by new or current students, it will be assessed tuition based upon the MBA/MHRM/M.ADMIN rates above plus mandatory student fees.

GBUS/MBA 801, 802 and 803 are for Business students in work placement courses. Tuition will be assessed at \$1,765.00 plus Mandatory Student Fees and the International Surcharge if applicable.

** URSU fees will be assessed as \$38.10/student plus \$4.85/credit hour. All students on campus and off campus, including Federated College students, are required to pay the Student's Union Fee. Student's Union Fees will not be assessed on off-campus contract classes.
