*Master of Public Policy and Johnson-Shoyama PhD students must register full time (six credit hours) in each semester, are considered full time and are assessed a flat tuition fee regardless of how many credit hours they are registered in.

JSGS 850 AA - ZZ For students registered in Johnson-Shoyama internship courses. Tuition will be assessed at \$1,148.50 plus Mandatory Student Fees based upon 6 credit hours according to the schedule above plus the International Surcharge if applicable.

*** The Master of Public Administration program has been changed from a 10 course program to a 12 course program. Students that are already enrolled in the 10 course program will be assessed tuition of \$469.50 per credit hour. New students will be enrolled in the 12 course program and will be assessed \$447.25 per credit hour.

~ URSU fees will be assessed as \$39.20/student plus \$4.95/credit hour. All students on campus and off campus, including Federated College students, are required to pay the Student's Union Fee. Student's Union Fees will not be assessed on off-campus contract classes.

** Student Health and Dental Plan - For the 201930 semester, all full-time graduate students (excluding credit hours from off-campus contract classes) are assessed an additional \$218.50 URSU Health & Dental fee. The fee is collected by the University on behalf of URSU and remitted to URSU for the purpose of paying the Health and Dental Plan premiums (\$93.85 for health coverage and \$124.65 for dental coverage). The fee is only assessed in the fall semester for health and dental coverage for 12 months beginning September 1. The Plan and the \$218.50 fee are mandatory, but students can opt-out of the health and/or dental coverage by October 1, 2019, if they provide proof that they already have health and/or dental coverage. Students first beginning classes in the winter semester can opt-in to the Plan from January 6, 2020 until January 31, 2020 by directly contacting studentcare.net/works. After the opt-out date, the premiums for the plan are non-refundable even if a student drops out of University. The student will continue to be eligible for benefits until the new plan year. ^ All full-time and part-time students enrolled in at least one on-campus course will be assessed an additional \$87.60 U-Pass Fee. The fee is collected by the University on behalf of URSU and remitted to URSU for the purpose of providing subsidized transit services as per the terms of the U-Pass Agreement established between URSU and the City of Regina. U-Pass and the \$87.60 fee are mandatory but students can opt-out if they meet the opt-out criteria. The opt-out period is from September 4, 2019 to October 1, 2019. **After October 1, 2019, the U-Pass fee is non-refundable even if a student drops out of University.** Details on the U-Pass program including pass activation, how to use the pass, opt-out criteria and the opt-out process can be found at www.ursu.ca/upass.
