EMBA students New students entering the program are assessed a program fee of \$53,305 over 3 semesters.
Full-time mandatory student fees are assessed each semester.
Current EMBA students will pay the program fee in effect when they entered the program as well as full-time mandatory student fees each semester.
If a class needs to be repeated, it will be assessed tuition based upon the MBA/MHRM/M.ADMIN rates above plus mandatory student fees.

GBUS/MBA 801, 802 and 803 are for Business students in co-op work placement courses. Tuition will be assessed at \$920.75.

~ URSU fees will be assessed as \$39.20/student plus \$4.95/credit hour. All students on campus and off campus, including Federated College students, are required to pay the Student's Union Fee. Student's Union Fees will not be assessed on off-campus contract classes.

Tuition Deposit

A non-refundable and non-transferable tuition deposit of \$1,000 is required within 20 business days of acceptance. If the student starts in the term indicated in the acceptance letter, the deposit will be applied to that semester's tuition; otherwise, the deposit is forfeited.
