MEMORANDUM OF UNDERSTANDING BETWEEN XIAMEN UNIVERSITY OF TECHNOLOGY AND UNIVERSITY OF REGINA

Recognizing the importance of sustaining the successful cooperative partnership between Xiamen University of Technology (XMUT), China and the University of Regina (U of R), Canada, XMUT has established the President's Scholarship Program to support the visit of faculty members of the U of R to participate in the academic life of XMUT.

The terms and conditions of the President's Scholarship Program provided by XMUT each academic year are as follows:

1. An annual scholarship in the amount of twelve thousand dollars Canadian (\$12,000) will be paid in monthly installments of one thousand dollars Canadian (\$1,000) to one candidate or to sharing candidates nominated by U of R.
2. The U of R scholarship recipients who visit XMUT for teaching or academic exchange will have free accommodation from XMUT comparable to that enjoyed by XMUT international teachers.
3. The U of R scholarship recipients will have access to XMUT's facilities, including but not limited to research facilities, libraries, labs and offices, on the same basis as XMUT faculty members.
4. XMUT International Office will send an official invitation letter to each U of R scholarship recipient to allow her/him to obtain the requisite visa/permit to come to China. However, all such applications are the responsibility of the U of R scholarship recipients.
5. XMUT International Office will arrange transportation for each U of R scholarship recipient to go from Xiamen International Airport to her/his residence and assist her/him with tasks such as banking, grocery shopping, etc.
6. XMUT will pay U of R scholarship recipients who undertake teaching opportunities at XMUT through the Joint Undergraduate Degree Program between U of R and XMUT. The payment will

be comparable to that of XMUT international teachers.

- 7. XMUT International Office and U of R International Office will discuss in November each year on the selected candidates for the subsequent year and her/his visit schedule.
- 8. This Memorandum of Understanding will operate for a period of five (5) years commencing on the date of signature by both parties, subject from time to time to revision or modification by mutual agreement. Representatives from both institutions will discuss the terms of a renewal at least six (6) months prior to the termination date defined by this Memorandum of Understanding.




