This collection contains the research and writing records of Maggie Siggins for the book: <u>Brian and the Boys: A Story of Gang Rape</u> (Toronto: James Lorimer & Company, 1984). Included are Hearing and Trial Proceedings, plus research files. The research files give one an inside look at the processes of investigative journalism. Included are Clippings files, Trial files, correspondence with researchers, plus individual biographies. The biographies especially illuminate the author's investigative skills, and contain her remarkable correspondence with Brain Dempsey. Finally, the collection contains rough drafts of the work on paper and computer diskettes, and sound recordings of interviews with both major and minor figures in the book. Sound recorded interviews for her book <u>Bassett</u> (Toronto: James Lorimer & Company, 1979) are also included.

Maggie Siggins was appointed to the Max Bell Chair of Journalism at the School of Journalism and Communications for the academic year 1983-84. Prior to this she held a variety of posts in the Toronto area.
