INTRODUCTION: The Royal Commission on Health Services of 1961 was an investigation of existing health services in Canada. The purpose of the Commission was to make recommendations for improvements to services. At the time Jack Boan was a member of the research staff for the Commission in Ottawa. He later joined the University of Saskatchewan, Regina Campus in 1962 as Professor of Economics. His contribution to the Commission was a 1964 report, "Group Practice", concerning the effect of group practice on the quality of medicine in Canada. Boan's involvement with the Royal Commission on Health Services introduced him to the subject of health economics and thus encouraged further research in this area.
