


Where We've Been

- Heavily dependent on growth in tuition revenue
- Nationally, enrolments have nearly doubled since late 1990s.
- Domestic tuition rates have been increasing recently by inflation plus 1% annually
- Tuition revenue by inflation plus 3%
- Growth in international students
- Growth in higher tuition programs (some new)

MIT Deems MicroMasters a Success

"Administrators at Massachusetts Institute of Technology say they are "floored" by the quality of students in its half online, half in-person master's degree program. Expansion plans are in the works.

"The results from the blended program in supply chain management are beginning to influence how MIT accepts students and offers graduate-level education. New programs are 'bubbling up through the system."

MIT Deems MicroMasters a Success

"Learners in the blended program take the first semester's worth of courses through the massive open online course (MOOC) platform edX, which MIT helped create. The courses are available for free, but learners who complete five courses and pay \$150 in identity-verification fees in each can earn a credential known as a MicroMasters.

"Those learners are then eligible to take a comprehensive final exam. Earning a passing grade makes them eligible to apply to complete the master's degree during a semester on campus."

"Doctoral Education for the Professional Sphere"

"Doctoral education in Canada is evolving. In response to shifting labour market realities and the demands of a more diverse student population, universities are integrating professional skills development into PhD programs and offering new types of PhDs altogether. One emerging alternative is the professional doctorate—a research degree that is equivalent to the PhD, but has an applied focus, often engaging working professionals who will employ their doctoral training in the professional sphere."

"Doctoral Education for the Professional Sphere"

- Professional doctorates are emerging as an applied, professionally oriented alternative to the traditional PhD.
- Royal Roads University's doctor of social sciences (DSocSci) is an interdisciplinary professional doctorate degree that facilitates action-oriented research on issues facing industry and society.
- The delivery and alternative knowledge-sharing formats used in the DSocSci could serve as a model for designers of both traditional and professional doctorate programs.

Facilities, library resources, etc.

Existing Programs

Cannibalizing existing programs

Ongoing Support

· Proponents over-commit, cannot sustain effort

Are Our Tuition Rates Right?

- Targeted discounts to attract students to programs with excess capacity
- More effective than automatic entrance scholarships based on high school grades? (see *University Affairs*, Oct 2017)
- Would we ever consider dynamic pricing?
- A university degree is still the investment with the highest rate of return available!



Increase Retention

- Increase undergraduate retention from first to second year by 1% and you increase total undergraduate enrolment by almost 1%.
- Easier to retain a student than recruit one?
- Cheaper to retain a student than recruit one?

Children's Camps

- During summer and school breaks
- Branded, high quality programs
- In addition to revenue generation,

 - > An introduction to your university for potential future students
 - > Possibly sponsorships
 - Residential camps can provide ancillary revenue
