Section	Parking Bylaw	Penalty (\$)
3.1	<b>Right of Way – Pedestrian</b> Pedestrians have the right-of-way in parking lots, at all pedestrian crossings, and on roads with no sidewalk providing they walk on the side facing traffic.	50.00
3.2	<b>Crossing</b> Pedestrians shall yield the right-of-way when not at a pedestrian crosswalk.	50.00
3.3	<b>No-Riders</b> No person shall stand on a road for the purpose of soliciting a ride.	50.00
3.4	<b>Waiting on Curb</b> Pedestrians waiting for traffic to pass must stand on the curb or sidewalk.	50.00
3.5	<b>Boarding</b> Except in the case of bicycles, no person shall step off or board a motor vehicle or attempt to step off or board a motor vehicle while it is in motion.	50.00
3.6	<b>Traffic Directions:</b> Pedestrians shall comply with any applicable traffic directions indicated on any traffic sign or given by any Parking Enforcement Officer or Peace Officer.	50.00
3.7	<b>Skateboards, Etc.</b> Skateboards, hover-boards, and stand-up scooters shall be limited to use as a means of transportation only and only used outdoors. No person shall perform or engage in any acrobatics or other stunts with these items.	50.00
4.1	<b>Bicycle Stand</b> Bicycle parking is permitted only in areas specifically designated by a bicycle parking rack/stand or a secure bicycle cage. Bicycles cannot be affixed to trees, rails, sign posts, or other objects not designed for the sole purpose of securing and storing bicycles.	45.00
4.3	<b>Right of Way – Bicycle</b> Bicycles operated on sidewalks shall yield the right of way to all pedestrians.	50.00
5.1	<b>Barricades</b> No operator of a motor vehicle shall drive through or enter upon any road, parking lot or portion thereof which is roped or tapped off, barricaded or indicated by any device, or sign as being closed or having restricted access.	100.00
5.2	<b>Dangerous Goods</b> No operator shall travel on University property with dangerous goods in excess of the allowable quantity without written permission by the President.	100.00
5.3	<b>Camping</b> No person shall park and camp overnight on University property in either a motor vehicle, tent, or trailer without permission of the President.	50.00
5.4	<b>Obstructing Free Passage</b> No Person shall obstruct the free passage of traffic or any pedestrian walk or road without written permission of the President.	60.00
5.5	<b>Parades</b> No Parades or processions shall be held on University property without the permission of the President.	60.00
5.6	<b>Unauthorized Use of Electrical Outlet</b> No operator shall plug a motor vehicle into an electrical outlet for which they are not authorized to do so, or for which they have not paid the fee. Operators shall not run an electrical cord into a non-electrified parking stall.	100.00

5.7	<b>Repair Motor Vehicles – Repair/Service/Clean</b> No operator shall wash, service, maintain, clean or repair a motor vehicle on campus except in the case of emergency repairs or where written permission has been obtain from the President.	50.00
5.8	<b>Uncoupled Trailers</b> No person shall leave a trailer or tractor-trailer unattached to their motor vehicle on any road, parking stall, bus stop, parking lot or any other place unless permission has been obtained from the President.	50.00
5.9	<b>Engine Running</b> No operator of a motor vehicle shall leave the engine running while loading or unloading goods at any loading dock or any location prohibited by a sign.	50.00
5.10	<b>Interference with Parking Signage</b> No person shall deface, alter, move, obstruct or interfere with any parking signage on campus property.	50.00
5.11	<b>Tampering with Equipment</b> No person shall deposit any substitute for coin or currency of Canada in a parking meter or Paystation. No person shall deface, alter, damage, tamper with or impair any parking meter, pole, Paystation, permit card reader, permit dispenser, parking lot gate, immobilizer, barricade, pylon or other equipment.	200.00
5.12	<b>Unauthorized Signs</b> No person shall erect or maintain any traffic or parking warning or directional sign unless written permission has been obtained from the President.	50.00
5.13	<b>Direction of Traffic Signs</b> No person shall disobey any applicable instructions or directions indicated on any traffic sign or parking sign unless otherwise directed by a Parking Enforcement Office or a Peace Officer.	50.00
5.14	<b>Directions of Parking Enforcement Officer or Peace Officer</b> Every person shall comply with any directions given by a Parking Enforcement Officer or Peace Officer pursuant to these Bylaws.	50.00
6.3	<b>Accessible Parking</b> No operator shall park a motor vehicle, or encroach in any way, on a space identified as Accessible Parking Space or on an Accessible Ramp, unless it is displaying a SaskAbilities placard or has an Accessible ePermit.	200.00
6.4.1	<b>Directional Parking – On Street/Loading Zone</b> Unless any on-street parking stall or loading zone is otherwise posted, no operator shall park a motor vehicle other than parallel with the curb, and with the right hand wheels within thirty (30) centimetres of the curb, nor shall any operator park, stand or stop a motor vehicle in any on-street parking stall or in a loading zone so that any part of the vehicle projects into a road.	50.00
6.4.2	<b>Directional Parking – Parking Lot/ Pay Parking Zone</b> Unless a parking stall within a parking lot or pay parking zone is otherwise marked (or designated for angled parking), all operators must park a motor vehicle ninety (90) degrees to the curb or parking rail, and with the front bumper no less than thirty (30) centimetres from the curb or parking rail.	50.00
6.4.3	<b>Directional Parking – LPR Parking Lot</b> No operator shall park a motor vehicle in any LPR parking lot other than facing forward unless displaying a licence plate on the front of the vehicle.	50.00

6.4.4	<b>Directional Parking – Driving Lane/Road</b> No operator shall park a motor vehicle in such a manner that the licence plate is not distinctly visible and legible from the driving lane or road.	50.00
6.4.5	<b>Directional Parking – Backing Into Parking Stall</b> No operator shall back a motor vehicle into a parking stall unless the vehicle displays a front licence plate that is clearly visible from the driving lane.	50.00
6.4.6	<b>Directional Parking – Left Hand Side to Curb</b> No operator shall park a motor vehicle with the motor vehicle’s left hand side to the curb unless allows by signs in the case of one direction traffic.	50.00
6.5.1	<b>Time Limited Parking</b> No operator shall park a motor vehicle beyond the time limit specified (i) by the parking signage, (ii) the time limit specified on the ePermit for the location, or (iii) the parking privileges paid for and obtained for the location.	50.00
6.5.2	<b>Exceeding Daily Time Limit</b> No operator shall park a motor vehicle in any time-limited Pay Parking Zone for more than the daily time-limit as indicated by parking signage.	50.00
6.5.3	<b>Meter Violation</b> No operator shall park a motor vehicle in a Pay Parking Stall if the meter timer indicates “Violation”, “Time Expired”, “Out of Order”, “Fail” or “00.00”, and if said motor vehicle does not otherwise have a valid ePermit for such location.	50.00
6.6	<b>Double Parking</b> No operator shall park their motor vehicle alongside one that is already parked at the side of the road for any purpose including loading/unloading.	50.00
6.7	<b>No Stopping on Campus Roads</b> No operator shall stop a motor vehicle on any road, except (i) when necessary to avoid collision or conflict with other traffic; or (ii) in compliance with the directions of a Parking Enforcement Officer, Peace Officer or traffic signs.	50.00
6.8.1	<b>Non-Designated Area</b> No operator shall park any motor vehicles in areas not designated for parking (such as, but not limited to, landscaped areas, undeveloped areas, roads, and sidewalks) without the written permission of the President.	50.00
6.8.2	<b>Reserved Parking Lot/Stall</b> No operator shall park a motor vehicle in a parking stall, Pay Parking Zone, or parking lot unless permitted for the privilege during the reserved period as indicated by parking signage.	100.00
6.8.3	<b>Bus Stop</b> No operator shall park, stand, or stop any motor vehicle in a bus stop. These areas are explicitly for bus use and the loading and unloading of passengers.	100.00
6.8.4	<b>Fire Hydrant</b> No operator shall park a motor vehicle within three (3) metres of a fire hydrant except for the purpose of loading or unloading, providing the operator remains at the wheel at all times ready to move when required.	100.00
6.8.5	<b>Obstruct Pedestrian Crossing</b> No operator shall park a motor vehicle so as to obstruct a pedestrian crossing.	100.00
6.8.6	<b>Encroach Adjacent Stall</b> No operator shall park a motor vehicle and encroach on adjacent parking stalls and must remain in the boundaries indicated by lines, poles, etc.	50.00

6.8.7	<b>Service Area – No ePermit or Parking Privilege</b> Except in the case of a service vehicle, no operator shall park a motor vehicle in a Service Stall or Service Area, or on a Service Road.	100.00
6.8.8	<b>Service Area – Time Limit Exceeded</b> The operator or a service vehicle may only park in a Service Area during such a time as the operator requires immediate access to their equipment. Service vehicles can only park for the posted Service Area time limit.	50.00
6.8.9	<b>Stall Occupied</b> No operator shall park a motor vehicle in a parking stall if the stall is already occupied by another vehicle.	50.00
6.8.10	<b>Unlicensed Motor Vehicle</b> No operator shall park a motor vehicle or trailer on University property unless it is a registered motor vehicle and is displaying a valid licence plate.	50.00
6.8.11	<b>Propane Motor Vehicle</b> No operator shall park a propane-fueled motor vehicle within an indoor enclosed parkade or indoor loading dock.	50.00
6.8.12	<b>Blocked Parking Stalls</b> No operator shall park a motor vehicle in a Blocked Parking Stall unless the motor vehicle has been issued a valid ePermit with privileges for that location.	100.00
6.8.13	<b>Fire Lane</b> No operator shall park a motor vehicle anywhere designated a Fire Lane, nor the entrance and exit of a parking lot or any access lane within a parking area.	100.00
6.9	<b>Opening of Doors</b> No person shall open a door of a motor vehicle on the side exposed to moving traffic unless it is reasonably safe to do so, nor shall any person leave a door of a motor vehicle open on the side exposed to moving traffic for a period of time longer than necessary to load and unload passengers.	50.00
6.10	<b>Abandoned Vehicles</b> No person shall park a motor vehicle in any location for longer than 72 hours unless permission has been obtained from the President.	50.00
6.11	<b>Motorcycles and Motorized Scooters</b> Motorcycles and motorized scooters are motor vehicles and must be parked in a parking lot or parking stall, or area designated for the parking of motorcycles and motorized scooters.	50.00
7.4.2	<b>Failure to Stop/Pay</b> During the hours of operation, on entry to a controlled Pay Parking Lot, the operator is required to stop and obtain a permit from the automated ticket dispenser. On exiting the controlled Pay Parking Lot, the operator is required to stop and pay the fee required at the Paystation. Failure to stop and pay the fee is a violation of these bylaws and the assessed fine is in addition to accumulated parking charges to be paid.	200.00
7.4.3	<b>Share Permit or FOB/Aid Vehicle</b> No person shall share or allow their authorized permit or FOB to be used in aiding a second, previous or subsequent motor vehicle(s) from exiting or attempting to exit a controlled parkade without paying.	200.00

<b>7.4.4</b>	<b>No Tailgating</b> No operator of a motor vehicle shall exit a Controlled Pay Parking Lot before allowing the gate to fully close after the previous motor vehicle.	100.00
<b>7.5</b>	<b>Additional Penalties</b> Any operator of an Unlawfully Parked Motor Vehicle is subject to receive an additional citation if the motor vehicle remains Unlawfully Parked after two (2) hours from the time the previous citation was issued.	50.00
<b>7.6.2</b>	<b>Affixing of Permit</b> If a physical permit is issued to an individual, the permit shall be affixed or so attached to the motor vehicle according to the instructions print on or provided with the permit.	50.00
<b>7.6.3</b>	<b>Removal of Permit</b> All permits which are no longer valid shall be removed from the motor vehicle.	50.00
<b>9.2.6</b>	<b>Interference with Removal or Immobilization</b> No person shall attempt to prevent the immobilization or removal of any motor vehicle or in any manner interfere with the immobilization or removal of any motor vehicle.	60.00
