The meeting was called to order at 2:30 p.m. by the President and Vice-Chancellor, Dr. Jeff Keshen.

In keeping with the University's commitment to Reconciliation, the Chair acknowledged that the University is located on Treaty 4 territories with a presence in Treaty 6. These are the territories of the nêhiyawak, Anihšināpēk, Dakota, Lakota, and Nakoda, and the traditional homeland of the Métis/Michif Nation.

## 3. Business Arising from the Minutes

3.1 Faculty of Arts Core Curriculum, Appendix I, Pages 3-65

**Moved that** Executive of Council approve revisions to the Faculty of Arts Core Curriculum, as outlined in Appendix I, Pages 3-65 of the Agenda, effective 202320.

Concern was raised regarding the impact on the Federated Colleges with the removal of BIOL 140: Human Biology for Non-Majors and BIOL 150: Biological Principles for Non-Majors. In response, it was noted that the impact on registration for these courses is expected to be minimal. It was further highlighted that removal of the lab requirement is expected to positively impact potential transfer credit opportunities for students transferring to the University of Regina.

The program template was amended to read:

"Note: Students who, as part of their admission to the Faculty of Arts, had to complete an English Language Proficiency test or who completed EAP 100 or and 101...."

The question was called on the amended motion.

# 3.2 New Program – Master's Certificate in Applied Artificial Intelligence

# A. Douai – P. Choi

**Moved to** created the Master's Certificate Program in Applied Artificial Intelligence as one of the graduate program options in the Program of Software Systems Engineering, Faculty of Engineering and Applied Science, effective 202320.

Concern was raised regarding the use of "artificial intelligence" in the title without specifying an Engineering program. This may be confusing for students due to the significant expertise in artificial intelligence housed within the Department of Computer Science. Additional concerns were raised with the program requirements, noting that students can obtain this credential without taking an artificial intelligence course. After discussion, the following subsidiary motion was made:
