## CURRENT COUNCIL COMMITTEE ON ACADEMIC MISSION TERMS OF REFERENCE

## Purpose:

As a voice of Council on the academic mission of the University, the Council Committee on Academic Mission shall recommend reports to Council on matters relating to the academic structure of the University (i.e. Faculties, Academic Units, affiliations or federations) and advise the President on matters that relate to academic planning, programs, academic unit reviews, and university strategic planning.

## Membership:

8 members of Council, with no more than 2 members representing a Faculty or Academic Unit 2 students, appointed by URSU and GSA, respectively Ex officio: Provost and Vice-President (Academic), Vice-President (Research), Associate Vice-President (Academic)

Resources: Provost and Vice-President (Academic) office

## Roles and Responsibilities:

1. To review, assess and prepare recommendations for the President on the University progress on the strategic plan and to provide such reports regularly (no less than once per year) to Council and Executive of Council.
2. To review and make recommendations to the President on academic planning and programming.
3. To participate, on Council's behalf, actively in the creation of future University strategic planning, reporting back to Council as required.
4. To consult regularly with the Council Committee on Budget for continuity and effective collaboration.
5. To review and make recommendation on the process for Faculty and Academic Unit reviews, receiving reports, and report to Executive of Council and Council, as required.
6. To report and recommend to Council on matters relating to the academic structure of the University (i.e. Faculty, Academic Units, affiliations or federations).

## PROPOSED COUNCIL COMMITTEE ON ACADEMIC MISSION TERMS OF REFERENCE

As a voice of Council on the academic mission of the University, the Council Committee on Academic Mission shall recommend reports to Council on matters relating to the academic structure of the University (i.e. Faculties, Academic Units, affiliations or federations) and advise the President on matters that relate to academic planning, programs, academic unit reviews, and university strategic planning.

## Membership:

8 members of Council, with no more than 2 members representing a Faculty or Academic Unit
2 students, appointed by URSU and GSA, respectively
Ex officio: Provost and Vice-President (Academic), Vice-President (Research), Associate Vice- President (Academic)

Resource: Provost and Vice-President (Academic) office
All committee members, including students and ex-officio members, have voting rights. Each member has one vote.

## Roles and Responsibilities:

1. To take an active role in strategic plan development through regular consultation with, and feedback to, the University's Strategic Plan committee.
2. To oversee and make recommendations concerning regularly scheduled Academic Unit reviews at the University of Regina, receiving reports, consulting with units on responses to, and progress on, Academic Unit Review recommendations, and reporting to Executive of Council and Council, as required.
3. To examine for approval new program proposals referred by CCUAS and CCFGSR, when questions as to possible program duplication or concerns as to implications for academic mission or quality have been raised at those Council committees.
4. To actively participate in the University's academic planning process through regular consultation with the academic planning committee or the academic planning lead and advise the President on academic planning and the implementation of the University's academic plan.
5. To consult regularly with the Council Committee on Budget for continuity and effective collaboration.
6. To report and recommend to Council on matters relating to the academic structure of the University (i.e. Faculty, Academic Units, Institutions and Centres that contribute to the University's academic mission, affiliations/federations, etc.)

## REPORT TO EXECUTIVE OF COUNCIL FROM THE COUNCIL COMMITTEE ON BUDGET 15 FEBRUARY 2023

In the past, CCB has typically reported to Executive of Council at the end of winter term, a time that coincides with the conclusion of the annual budget making process. This report pertains to the CCB work during this academic year.

Since September 2022, CCB has held its regular monthly meetings during Fall 22, and two meetings January 2023. Throughout this period, the ex-officio members of the committee have kept CCB appraised of the very challenging budget situation of the University. Specifically, in its November meeting CCB was presented with the 2023-24 Budget Discussion document that outlines the specifics of these challenges and the expected budget parameters for next year.

CCB had a very engaged participation of the membership in these meetings to discuss these fiscal challenges and to provide input on related matters. Given the gravity of the situation, CCB has continuously advocated to the senior administration the importance of raising awareness about the financial situation and the need for difficult decisions to the campus community. Specifically, we have suggested reviving the practice of Budget fora to campus community as a means to raise awareness.

As you may be aware from other university communications, the decline in tuition revenues due to lower than expected student enrolments, along with cost increases due to inflation have resulted in a structural deficit of about $\$ 20 \mathrm{M}$ in the operations alone. Addressing this structural deficit would require a significant overall reduction in the operating base budget that would be applied across the next three years.

Given its advisory role, CCB has also advocated for more clarity on its expected work within the budget making process. As per process of making the 2023-24 Budget, the Budget Team has lately issued to budget managers a call for submission of scenarios considering a $5 \%, 6 \%$ or $7 \%$ base budget cuts in the first year, also outlining impacts on their units. Given the sensitive nature of actions contemplated to achieve such reductions, the review and presentations of submissions will be limited only to the Budget Team who is expected to draft and present the budget by end of April.

While minutes provide an account of matters discussed in CCB meetings, the overall sentiment is that to address the budgetary challenges beyond the 2023-24 upcoming cycle, there is a need for deliberate changes that are perhaps more structural in nature.

### 2.2 Faculty of Education Dean's Honours List - Revision

MOTION: To revise the Faculty of Education Dean's Honours List regulation, effective 202330.

Dean's Honours List (As per page 157 of the 2022-23 UG Calendar)
Fo be included on the Dean's Honours List for a given term, students must achieve a term grade point average (TGPA) of at least $85.00 \%$ on a minimum of 15 credit hours, of which 12 credit hours are numerically graded. The designation "Dean's List - Education" is recorded on the official transcript.

To be included on the Dean's Honours List for a given term, students must achieve a term grade point average (TGPA) of at least $85.00 \%$ on a minimum of 9 numerically graded credit hours in a single term. The designation will be noted on the official transcript.

## Rationale:

To allow those students who do not take a full course load to be included on this designation, while aligning with the University's definition of full-time studies.

## 3. REGISTRAR'S OFFICE

### 3.1 Instructor Responsibilities - Calendar Revision

MOTION: To revise Instructor Responsibilities in the Academic Regulations section of the undergraduate academic calendar, effective immediately.
11. Ensure that there are no classes during the fall and winter breaks. No tests, quizzes, or exams can be held in the fall and winter break and, no class assignments can be due during this week.

## Rationale:

To clarify the purpose of the fall and winter breaks and to provide clear guidelines for instructors concerning what is not allowable during these breaks. The purpose of a week-long break in the fall and winter terms (traditionally known as the "reading week") is to give students an opportunity to catch up on their studies.

### 3.2 Undergraduate Student Leave of Absence - New Calendar Regulation

MOTION: To approve the following Leave of Absence regulations to be added to the Academic Regulations section of the undergraduate academic calendar, effective immediately

## Leave of Absence

Except for the Faculty of Nursing where a formal leave of absence is required (see Faculty of Nursing), University of Regina undergraduate students do not need a formal leave of absence for a period of 3 terms or less. Students will remain active in their programs for a period of 3 terms without having to formally register in courses. In situations of maternity or parental leave, students may apply for a formal leave of absence for an additional 2 terms for a maximum of 5 consecutive terms. Students must submit their leave of absence request a month prior to the end of the third term of course inactivity.

Note - International students who are studying on a study permit need to ensure that they are in compliance with the regulations of their study permit and may not be eligible for a leave of absence as a result of those regulations.

## Rationale:

At the undergraduate level students have three full terms where they can remain active without having to register for courses and petition for re-admission. While this is generous, it does not recognize situations of maternity and parental leave where students may need a longer leave period before returning to studies. The extended leave period will allow for maternal/parental situations to be considered so that the student does not need to reapply for admission and potentially losing previously completed course work as a result of program regulation changes.
