A question was raised why the Pre-Social Work and the Indigenous Social Work Qualifying admission requirements no longer require science and math. Dean Rocke agreed that the Faculty of Social Work would withdraw this motion, to allow further discussion and consideration.

A further question was raised regarding the University's use of quotas during the admission process. It was clarified that the Faculty of Nursing is the only Faculty with admission limits.

Dean Hussein noted that the qualifying program will provide them the opportunity to complete an equivalent course at University of Regina and allow them to be supported by the Faculty of Engineering and Applied Science.

Interim Dean Evans responded to a question related to "attempted" courses. She also clarified that Nursing applicants with previous post-secondary education would be admitted based on their performance in at least 15 and up to 30 credit hours of previous post-secondary courses.

<u>Admission Regulation Revision – Admission Grade Point Average for the Bachelor of</u> Social Work

**Moved to** revise the calculation of the Bachelor of Social Work Admission Grade Point Average, effective 202130.

A Senator noted that there were inconsistencies between these and similar motions from other faculties. Dr Chase noted that these motions are considered by faculty councils, assessing the needs of their specific prospective students and the characteristics of their programs.

#### English Language Proficiency Test - Duolingo

**Moved that** the Duolingo Online English Test with a minimum score of 110 be accepted as an approved test of proficiency in English for undergraduate admissions, on a temporary basis for the 2021-2022 academic year (July 1 to April 30), effective July 1, 2021.

In response to a question, the Registrar confirmed that the Duolingo Online English Test is being approved temporarily, as other English Language Proficiency tests have not been consistently available through the pandemic.

In response to a question, the Registrar noted that this revision will clarify current practice to ensure that the 60.00% UGPA requirement applies to all University of Regina credit-based credentials (degrees, diplomas, and certificates).

8.1 Board Members Elected by Senate, Verbal Update

A. Opseth and M. Smadu provided a brief update on the activities undertaken by the Board of Governors since the last meeting of Senate, which included the following:

At the March meeting, the Board approved:

- 2021 University Risk Register
- Annual Internal Audit Plan
- Changes to the governance structure of the TRIUMF laboratory, of which the University is a member
- Preventative Maintenance Renewal Projects
- An update to the Research Institutes and Chairs Policy
- Research Chairs, including the Gabriel Dumont Chair in Métis/Michif Education, the President's Research Chair, and the Chancellor's Research Chair

The Human Resources Committee received the Annual Health, Safety, and Wellness report which included information on the newly created Mental Wellness Hub.

The Board heard a presentation from Dr H. Riemer and L. Robertson from the Faculty of Kinesiology and Health Studies on the "Promotion of Wellness and the Dr Paul Schwann Centre."

At the May meeting, the Board approved:

- 2021-2022 Comprehensive Budget plan, including the tuition and fee levels for the upcoming year
- 10 Year Capital Plan
- Canadian Institute for Advanced Research Chair in Artificial Intelligence

The Board welcomed Hannah Tait, the new University of Regina Students' Union President (URSU), who is also an ex-officio member of the Board of Governors.

The Board heard the presentation from Dr G. Pennycook on "Intuition, Reason, and Social Media" which the Senate had previously heard in February.

The Presidential Transition Committee has begun its work with Dr J. Keshen to support him as he begins his presidency.

The next regular meetings of the Board of Governors are scheduled for July and September.

The Chancellor thanking Dr Opseth and Dr Smadu for the update.

#### 9. **Academic and Administrative Reports**

9.1 Annual Enrolment Report 2020-2021, For Information, Appendix IV, Pages 66-70

J. Smith, Associate Vice-President (Student Affairs), presented the report and highlighted the five-year enrolment trends, population segments, and the top nations for international recruitment.

Discussion followed. Topics of discussion included:

- 11% increase in the Spring/Summer 2021 enrolment headcount and the factors contributing to the increase in student enrolment
- International student enrolment and expected return to pre-pandemic levels

The Chancellor thanked J. Smith for the report.

9.2 "University Pandemic Recovery and Welcome to our New President," presentation by Dr d. Gregory, Dr K. McNutt, and Dr J. Keshen

The Chancellor introduced Dr Gregory and Dr McNutt to Senate.

After the presentation, discussion followed. Topics of discussion included:

- Incoming students and their readiness for University
- Impact of the pandemic on research and how it will continue to impact the University going forward
- Positive comments received from the external community regarding how well the University has handled pandemic response

Interim President Chase provided thanks to all those who were involved in the pandemic response and recovery.
