President Keshen provided a verbal update on recent activities since the last meeting of Senate, including:

A warm welcome to Dr. Isabelle Dostaler who began her term as Provost and Vice-President (Academic) at the beginning of June. The search for the Vice-President (Research) is still ongoing.

The University is exploring additional dual credit options for Saskatchewan high school students. In addition, the University is expanding its programming in the province by signing various memorandum of understandings (MOU) with regional colleges. The University will be entering a partnership with North West college to collaborate on the joint delivery of a community-based Bachelor of Social Work program.

The University is excited to announce the recent creation of the Lieutenant Governor's Award for Teaching Excellence. This provincial award was initiated by staff from the University of Regina to highlight the work of academics across the province.

7.2.6 Centre for Continuing Education

A Senator commended the Centre for Continuing Education for the creation of the Advanced Certificate in Public Relations and Communications Management as it addresses a need within the public relations community. Moved to admit applicants who completely achieved Canadian Language Benchmark (CLB) 7 or 8 through participating in Language Instruction for Newcomers to Canada (LINC) classes to the EAP 100 level courses, effective 202330.

Dean Schultz clarified that the two motions provide an admission pathway for newcomers to Canada to meet the English Language Proficiency requirements for the University.

7.3.1 Faculty of Graduate Studies and Research

Moved that the online Duolingo English Test (DET) be accepted as an approved test of English Language Proficiency (ELP) for graduate admission (except for La Cité universitaire francophone), on a permanent basis, effective immediately.

A Senator inquired why Nursing was excluded from the motion. Dean Pollard clarified that the Faculty of Nursing followed the English Language Proficiency requirements of the College of Registered Nurses of Saskatchewan. This allows nursing graduates to immediately enter the workforce.

8. Briefs, Submissions, or Recommendations from Elected or Appointed Representatives of Senate

8.1 Board Members Elected by Senate, Verbal Update

A. Russell and M. Smadu provided a brief update on the activities undertaken by the Board of Governors since the last meeting of Senate, which included the following:

At the March Board meeting, the Board approved:

- 2023 University Risk Register
- Annual internal audit plan for 2023-2024
- Budget increase for a window replacement project for the Dr. John Archer Library and the Administrative Humanities Building
- Change to the Master Trust and Trust & Endowment investment custodian
- An increase to parking rates
- Faculty-based research centre, the Centre for Artificial Intelligence, Data, and Conflict

The board received regular annual reports on international activity, insurance, and health, safety, and wellness.

The Board received a presentation on Budget Principles and Assumptions and information on tuition comparatives and affordability.

The Board toured the Brad Hornung Accommodations Test Centre and the Centre for Experiential and Service Learning.

At the April Board meeting, the Board approved:

- 2023-2024 Tuition and Fees
- 2023-2024 Comprehensive Budget Plan
- 10 Year Capital Plan for submission to the Ministry of SaskBuilds and Procurement

The Audit and Risk Management Committee received a report on the University's Top 10 risks and reviewed the 2022-2023 Annual Report on Risk.

The Human Resources Committee reviewed and received the 2022 Annual Pension Plan reports.

The Financial and Facilities Committee continues to receive regular updates on Indigenous procurement initiatives.

Two Board members' terms have expired: David Chow and Gary Bosgoed. The Lieutenant Governor will appoint new members by Order-in-Council. The Board welcomed Tejas Patel, President, University of Regina Students Union (URSU). In addition, Dr. Andrew Cameron will begin as the Faculty member elected to the University of Regina Board of Governors on July 1st.

Following the report by the Board Members Elected by Senate, Senators were invited to ask questions. Discussion followed and included:

- Impact of increased tuition on domestic and international students
- Opportunity to offer additional scholarships and bursaries to international students

The Chancellor thanked A. Russell and M. Smadu for their report. The Chancellor extended thanks to M. Smadu for her service to the University of Regina as her term as a Senate Representative to the University of Regina Board of Governors comes to an end.

9. Administrative Reports

9.1 Annual Enrolment Report 2022-2023, For Information, Appendix VI, Pages 45-47

J. D'Arcy, Registrar, presented the report and highlighted five-year enrolment trends, populations segments, and the top nations for international recruitment.

Following the report from J. D'Arcy, Senators were invited to ask questions. Discussion followed and included:

- Examples of countries included in the "other" category. The University welcomes students from over 100 different countries
- Reasons for the decrease in students attending from China, noting that the University of Regina was one of the earliest to actively recruit from that nation
- Improvements in visa processing times for international students
- Changes in admissions and expectations of domestic students since the pandemic
- Introduction of hybrid and hyflex courses and the difference between these two modes of delivery

All questions were addressed by management.

10. Presentation

10.1 "EYES (Educating Youth in Engineering and Science)," presentation by K. Mullock, and M. Chittenden, Coordinators, Engineering Outreach

P. Choi introduced K. Mullock and M. Chittenden, Coordinators, Engineering Outreach to the University of Regina Senate.

After the presentation, discussion followed. Topics of discussion included:

- EYES partnership with the Saskatchewan Science Centre
- Recruitment and retention efforts of EYES to encourage students who attend the summer programming at a young age attend the University of Regina later in their educational journey
- Cost of programming and how EYES is funded

A Senator commended EYES on their efforts to introduce young people to science, technology, engineering, and mathematics in rural Saskatchewan.

The Chancellor thanked K. Mullock and M. Chittenden for their presentation.
