- Master of Business Administration (MBA)

Current

Mid-Career Option

A limited number of mid-career managers with at least 7 years work experience, but who lack an undergraduate degree, may be admitted to the Master's Certificate program. Mid-career managers must meet the Master's Certificate qualifying course requirements before beginning graduate courses, if they have not been completed prior to acceptance. These qualifying course requirements consist of ten (10) undergraduate courses. All qualifying courses must be passed with a grade no less than 70%. Qualifying students may be discontinued from their program if they receive one grade less than 70%. Mid-career managers who plan to take qualifying courses should consult with the Graduate Advisor in the Faculty of Business Administration to choose suitable courses.

Proposed

Mid-Career Option

A limited number of mid-career managers with at least 7 years work experience, but who lack an undergraduate degree, may be admitted to the Master's Certificate program. Mid-career managers must meet the Master's Certificate qualifying course requirements before beginning graduate courses, if they have not been completed prior to acceptance, or have achieved a minimum GMAT (or GRE equivalent) score of 500. The qualifying course requirements consist of ten (10) undergraduate courses. All qualifying courses must be passed with a grade no less than 70%. Qualifying students may be discontinued from their program if they receive one grade less than 70%. Midcareer managers who plan to take qualifying courses should consult with the Graduate Advisor in the Faculty of Business Administration to choose suitable courses.

Rationale:

In order to more appropriately recognize and account for the value of prior learning of individuals with extensive work experience, we added the GMAT/GRE exam as another option for the mid-career path. This additional requirement ensures the academic readiness of applicants who do not have the current ten undergraduate courses. It is an appropriate balance of ensuring academic readiness to graduate level standards and it creates pathways that recognize prior learning through relevant work experience.

Mid-Career Option

A limited number of mid-career managers with at least 7 years work experience, but who lack an undergraduate degree, may be admitted to the MAdmin program. Midcareer managers must meet the degree's qualifying course requirements before beginning graduate courses, if they have not completed prior to acceptance. These qualifying course requirements are ten (10) undergraduate courses. All qualifying courses must be passed with a grade no less than 70%. Qualifying students may be discontinued from the program if they receive one grade less than 70%. Mid-career managers who plan to take qualifying courses should consult with a Graduate Advisor in the Faculty of Business Administration to choose suitable courses.

Proposed

Mid-Career Option

A limited number of mid-career managers with at least 7 years work experience, but who lack an undergraduate degree, may be admitted to the MAdmin program. Mid-career managers must meet the degree's qualifying course requirements or have achieved a minimum GMAT (or GRE equivalent) score of 500 before beginning graduate courses, if they have not completed prior to acceptance. The qualifying course requirements are ten (10) undergraduate courses. All qualifying courses must be passed with a grade no less than 70%. Qualifying students may be discontinued from the program if they receive one grade less than 70%. Mid-career managers who plan to take qualifying courses should consult with a Graduate Advisor in the Faculty of Business Administration to choose suitable courses.

* Students entering with a Master's Certificate from the Levene School are not required to submit the results of an additional GMAT/GRE exam.

A limited number of mid-career managers with at least 7 years work experience but who lack an undergraduate degree, may be admitted to the MHRM program. Mid-career managers must meet the degree's qualifying course requirements before beginning graduate courses, if they have not been completed prior to acceptance. These qualifying course requirements are ten (10) undergraduate courses. All qualifying courses must be passed with a grade no less than 70%. Qualifying students may be discontinued from their program if they receive one grade less than 70%. Mid-career managers who plan to take qualifying courses should consult with a Graduate Advisor in the Faculty of Business Administration to choose suitable courses.

Proposed

Mid-Career Option

A limited number of mid-career managers with at least 7 years work experience but who lack an undergraduate degree, may be admitted to the MHRM program. Mid-career managers must meet the degree's qualifying course requirements or have achieved a minimum GMAT (or GRE equivalent) score of 500 before beginning graduate courses, if they have not been completed prior to acceptance. The qualifying course requirements are ten (10) undergraduate courses. All qualifying courses must be passed with a grade no less than 70%. Qualifying students may be discontinued from their program if they receive one grade less than 70%. Mid-career managers who plan to take qualifying courses should consult with a Graduate Advisor in the Faculty of Business Administration to choose suitable courses.

Mid-Career Option

A number of individuals with at least 7 years suitable work experience, but who lack an undergraduate degree, may be admitted to the Levene MBA with Specialization. These individuals must meet the degree's qualifying course requirements before beginning graduate courses, if they have not completed prior to acceptance, or the Post Graduate Diploma. These qualifying course requirements are ten (10) undergraduate courses and the GMAT score of 500 or GRE equivalent. All qualifying courses must be passed with a grade no less than 70%. Qualifying students may be discontinued from the program if they receive one grade less than 70%. Individuals who plan to take qualifying courses should consult with a Graduate Advisor in the Faculty of Business Administration to choose suitable courses.

Note: Admissions to the Levene MBA Public Safety, International Management, and Engineering Management specializations are currently suspended.

***A small number of students, with a GPA of 80% and GMAT score over 600 (or GRE equivalent), may be admitted without the required two years of work experience.

Proposed

Mid-Career Option

A number of individuals with at least 7 years suitable work experience, but who lack an undergraduate degree, may be admitted to the Levene MBA. These individuals must meet the degree's qualifying course requirements or have completed a Master's Certificate program before beginning the Levene MBA program, if they have not completed prior to acceptance, or the Post Graduate Diploma. *The* qualifying course requirements are ten (10) undergraduate courses and the GMAT score of 500 or GRE equivalent. All qualifying courses must be passed with a grade no less than 70%. Qualifying students may be discontinued from the program if they receive one grade less than 70%. Individuals who plan to take qualifying courses should consult with a Graduate Advisor in the Faculty of Business Administration to choose suitable courses.

***A small number of students, with a GPA of 80% and GMAT score over 600 (or GRE equivalent), may be admitted without the required two years of work experience.

Rationale:

The Master of Administration - Leadership, Master of Human Resource Management, and Master of Business Administration Programs align with the Master's Certificate to allow students to smoothly

ladder from a Master's Certificate into the Master of Administration - Leadership, Master of Human Resource Management, and Master of Business Administration Programs. This will ensure that we appropriately recognize individuals who have extensive work experience but do not have the current requirement of ten undergraduate courses. It is an appropriate balance of ensuring academic readiness to graduate- level standards and it creates pathways that recognize prior learning through relevant work experience.

2. COUNCIL COMMITTEE ON UNDERGRADUATE ADMISSIONS AND STUDIES

2.1 Faculty of Arts

2.1.1 Admission Suspension – Bachelor of Geographic Information Science

MOTION: To suspend admission to the Bachelor of Geographic Information Science (BGISc) program, effective 202420.

Rationale:

The Department of Geography and Environmental Studies has only one faculty member left who regularly teaches the geomatics core courses of the program. It is not feasible to offer the program without additional faculty members. The Department of Geography and Environmental Studies will mount all required courses (or identify substitute courses) for students who are currently enrolled in the program so they will be able to finish their degree as planned. Students who are admitted in Fall 2023 and Winter 2024 will also be supported in the completion of this program. The Department of Geography and Environmental Studies has confirmed that the Minor in Geographic Information Science will remain active.

2.2 Faculty of Social Work

2.2.1 Admission Requirements – School of Indigenous Social Work

MOTION: That students can only be admitted to one School of Indigenous Social Work program at one time, effective 202420.

The following criteria will be added to the Admission to Indigenous Social Work Qualifying section of the Undergraduate Calendar:

Admission to Indigenous Social Work Qualifying

New students first apply to the University of Regina.

All students who check FN University and put social work as their 'Program of Study' on the U of R application will be placed in the INSW Qualifying category. Once they have successfully completed the qualifying requirements, they apply

to the SISW for admission. See Academic Requirements INSW Qualifying section below and the Application and Admission to the BINSW/CINSW section below. Students who have not been accepted into the SISW through the admissions process may not take any INSW courses other than those noted in the qualifying requirements. The <u>Program Coordinator Chair of the School of Indigenous Social Work program Department Head of Indigenous Education, Health and Social Work (DIEHSW) of which the SISW is part, may make exceptions upon written request. Visiting students must go through the appropriate process to enroll in INSW courses. <u>Students can only be admitted to one School of Indigenous Social Work program at one time.</u></u>

Rationale:

This revision will align with the criteria outlined on pg. 32 in the 2023-2024 Undergraduate Calendar-Adding a Second Program in the Admissions section it outlines the criteria for adding a second program.

Adding a Second Program

Students interested in completing the academic requirements of two different programs at the same time, must discuss this option with an academic advisor in their current (Primary) program. Referring to the table below, adding an "Internal Secondary" program indicates both programs are within the same faculty and do not require a formal application. Adding an "External Secondary" program indicates both programs are not in the same faculty and will require a formal application using an Application for Undergraduate Concurrent Curricula Program form. Admission to a Secondary program is dependent on approval of both the student's Primary and the potential Secondary program. Faculties that allow Secondary programs may have restrictions on the programs available. For additional information refer to the section on Awarding of Additional and Concurrent Degrees.

Rationale:

The length of the CINSW program, at 66 credit hours, is more than other certificates. By renaming the Certificate program to a Diploma program, it will bring the program in line with the University of Regina Credential Framework. A certificate is often a program that takes less than 2 years to complete and often is obtained after only a few months of study. Diplomas are primarily offered by universities. They usually require a minimum of two years of study. If the name of this program is changed, more students would be drawn to it as an option and can transition into the four-year Bachelor of Indigenous Social Work program. The naming of this program to Diploma of Indigenous Social Work (DINSW) brings it in line with similar programs in the Faculty of Arts and the Faculty of Business Administration at First Nations University of Canada and University of Regina.

2.2.3 Graduation Requirements – School of Indigenous Social Work

MOTION: To include the following criteria to the Graduation Requirements for the SISW program, effective 202420.

Graduation

Refer to the Graduation section in this Calendar for general information. BSW students must have a minimum GPA of 70.00% on the social work studies section of the BSW program and a minimum PGPA of 70.00% on the 120 credit hours contributing to the degree (as of May 2018).

To graduate with a BSW students must complete at least 60 credit hours of social work courses, as required in the July 2000 CASSW Accreditation Standards. Forty-five of these 60 social work credits must be completed through the University of Regina.

To graduate with a BSW as an additional degree, students who have a four-year prior degree must complete a minimum of 45 social work credits over and above their previous degree. These must all be completed through the University of Regina.

In order to graduate with a BINSW or <u>DINSW</u>, or a <u>CINSW</u>, students must achieve a GPA of 70.00% on social work courses and an overall PGPA of 70.00% on all courses contributing to the degree or certificate.

Students who already have earned or successfully completed a BINSW degree may not subsequently be awarded the Diploma of Indigenous Social Work (DINSW). Students who have completed the Diploma of Indigenous Social Work (DINSW) requirements must have the Diploma of Indigenous Social Work (DINSW) conferred at least one convocation term prior to graduating with a BINSW.

The Faculty of Social Work does not have "Distinction" or "Great Distinction" graduation categories for the BINSW.

Rationale:

The Diploma is meant to ladder into the degree. By graduating with the DINSW after BINSW, it implies the DINSW is an advanced or post-BINSW certificate, which it is not. This addition is to align and clarify the Admissions Regulation – Adding a Second Program on p. 32 in the 2023-2024 Undergraduate Calendar. Information can be found p. 334 in the 2023-2024 Undergraduate Calendar.

2.2.4 Application Deadline – Indigenous Social Work Admission Application

MOTION: That the admission application deadline to the Indigenous Social Work programs be changed to May 15 and January 15. Exceptions will be determined by the School of Indigenous Social Work Program Coordinator Chair, effective 202410.

The following criteria will be added to the Admission to Indigenous Social Work Qualifying section of the Undergraduate Calendar:

Application and Admission to the BINSW/CDINSW

Application Information

Students may pick up their application package either at the Indigenous Social Work program office of FNUniv Saskatoon Campus or Student Success Services of FNUniv Northern Campus and Regina Campus.

The completed application is forwarded to the Saskatoon Campus, Administrative Assistant.

The deadlines to apply are March 1 May 15 and November 1 January 15. Exceptions determined by Department Head Program Chair in-committee.

Calculation of the BINSW/EDINSW Admission GPA

The grade point average (GPA) for admission to the CISW DINSW and BINSW programs is calculated using the applicant's grades earned in their most recent approved courses, to a maximum of 30 credit hours. This includes courses from the University of Regina and other post-secondary institutions attended and is not limited to successfully completed courses.

Rationale:

The decision of the School of Indigenous Social Work finds it more appropriate for students to apply twice per year. This statement will be included in the application package for Indigenous Social Work to take effect immediately. The application deadline dates better align with the end of the semesters to include final grades of the previous semester. Information can be found p. 338 in the 2023-2024 Undergraduate Calendar.

Background:

These certificate programs were created in 2019 to address two specific student cohorts. The Certificate in Nursing Foundations was created for those students who may be interested in Nursing but not accepted to the Nursing degree either due to capacity or due to missing admission requirements.

The Nursing Foundations Certificate was created as a pathway for applicants to the After Degree Nursing Program who do not meet admission requirements.

Rationale:

There has been some confusion as to which students should take which program. In addition, there is enough overlap in the two certificates that students could be admitted into one program to fulfill both needs.

Students will have until fall 2026 to complete the existing programs.

MOTION: To create a Bachelor of Design Degree, effective 202410.

Background and Description:

Bachelor of Design Degree (60 credit hours + 60 transfer credits)

Academic Requirements: Students must achieve a Program GPA of 65% to graduate.

Program Overview: This is a two-year post-diploma program (60 credit hours) that would allow direct entry for students who had completed a Diploma in Design at approved Canadian institutions or students who complete a Diploma in Creative Technologies or a Diploma in Computer Science at the University of Regina. A post-diploma baccalaureate program is a program that requires a post-secondary diploma for the purposes of admission where students receive a block of 60 transfer credits and are required to complete 60 University of Regina credit hours).

Courses required within the program will be offered at times convenient to off-campus students, as well as in the traditional day slots.

Total length:

60 block transfer credits

20 U of R courses

Design (DES): 6 courses

Media, Art, and Performance (MAP) and Creative Technologies (CTCH) courses: 6 courses

Critical Competencies: 8 courses

For admission to the **Post-Diploma Bachelor of Design** program, students must have completed:

- · The University of Regina Diploma in Creative Technologies;
- · Or, the University of Regina Diploma in Computer Science (DipCS);
- · Or the Diploma of Graphic Communications from Saskatchewan Polytechnic with a minimum GPA of 60.00% and ENGL 100 or equivalent;
- · Or, the Diploma of Interactive Design and Technology from Saskatchewan Polytechnic with a minimum GPA of 60.00% and ENGL 100 or equivalent;
- · Or, the Diploma of Engineering Design and Drafting Technology from Saskatchewan Polytechnic with a minimum GPA of 60.00% and ENGL 100 or equivalent.

Graduation from a similar, Canadian diploma program may be used for admission to this program and will be reviewed on a case-by-case basis. Students meeting the requirements will be granted admission to this degree program.

Rationale:

Environmental scans confirm that there is demand for a Design degree in Saskatchewan, there is demand for graduates with Design credentials in the workforce in Saskatchewan, and there are many Design Diploma graduates in Saskatchewan every year.

At the May 2023 Executive of Council meeting, it was moved that the Bachelor of Design Degree be reviewed by the Council Committee on Budget due to the budget implications of this program.

The Council Committee on Budget passed a motion at its meeting of 29 May 2023 to support the creation of the Bachelor of Design Degree contingent on additional information being provided on revenues and expenditures to better support the business case and/or the claim that this program will be a net revenue generating program. CCB noted that this was important for accountability if and when there may be a review about the fiscal sustainability of the program once it is up and running.



Background and Description

Headcount

Headcount represents the number of registered students in fulland part-time studies.

The University system first day of class headcount for the fall 2023 term was 16,860 up 893 students or 5.6% from the fall 2022 term and up 2.4% from the fall 2019 term. The undergraduate headcount was 14,358, an increase of 577 students or 5.6% and down by 86 students or -0.6% from the fall 2019 term. The graduate headcount was 2,502, an increase of 127 students or 5.3% and up 478 students or 23.6% from the fall 2019 term.

Faculties with increases at the U of R proper in undergraduate headcount include Science (19.9%), the Centre for Continuing Education (16.2%), Kinesiology & Health Studies (15.4%), Arts (11.9%), Business Administration (8.5%), Nursing (2.7%), Engineering (2.5%), and Social Work (1.3%). Media, Art, and Performance as well as La Cite are flat from 2022 and Education has seen a decrease of 56 students (-3.8%).

Overall, the Federated Colleges have year over year decreases with the exception of the Luther College which is flat from the fall 2022 term.

From a five-year perspective, the headcount in the fall term of 2019 was 16,468. This represents an increase in headcount of 2.4% (392 students) and an indication that the U of R is showing strong signs of enrolment recovery.

Credit Hours

Total registered credit hours represent the credit hours students register in. Total teaching credit hours represents the credit hours taught in each faculty.

The first day of classes registered credit hours for the fall 2023 term were 165,926, up 8,208 credit hours or 5.2% from the fall 2022 term and flat from the fall 2019 term with a slight decrease of 423 credit hours.

Notable increases in teaching credit hours for the U of R proper at the undergraduate level include the Centre for Continuing Education (29.4%), Media, Art, and Performance (15.4%), Engineering (9.6%), Science (9.4%), Arts (8.6%), La Cite (6.4%), Kinesiology & Health Studies (4.2%), Business Administration (3.5%), and Education (1.1%). The teaching credit hours in Nursing are flat and Social Work has a -4.5% decrease.

Credit Hours - continued

At the Federated Colleges, we see a decrease in credit hours taught of -1.2% at Campion College, an increase of 12.0% at Luther College, and and increase of 1.6% at First Nations University of Canada.

The Faculty of Graduate Studies and Research has an increase in registered credit hours of 177 (12.61%). A breakdown of credit hours taught by faculty is not available.

Full Load Equivalents (FLE) and Average Registered Credit Hours

Full load equivalents (FLE) are determined by taking the total number of registered credit hours and dividing by 15, which is considered to be the 100% course load of a full-time student at the undergraduate level. The FLEs generated by undergraduate students are equivalent to 10.364 FLEs which is up 465 FLEs (4.7%) from fall 2022.

The average registered credit hours at the undergraduate level is 10.8 per student and remains relatively flat compared to previous years.

Because there are a variety of circumstances that contribute to FLE at the graduate level, FLE is not reported at this level.

Population Segments

Domestic Students

The headcount for domestic students on the first day of classes in the fall 2023 term was 10,375 down 199 students or -1.9% from the fall 2022 term.

Self-Declared Indigenous Students

The headcount for self-declared Indigenous students on the first day of classes in the fall 2023 term was 2,337 down 34 students or -1.4% from the fall 2022 term.

International Students

The headcount for international students on the first day of classes in the fall 2023 term was 4,148 showing an increase of 1,126 students or 37.3% over the fall 2022 term.

India continues as the top sending nation with a headcount of 1,690 students on the first day of classes. This is followed by Nigeria (1,044), Bangladesh (264), China (250), and Iran (175).

Graduation and Convocation: Spring 2023

The University conferred 2,545 certificates, diplomas, and degrees in the spring of 2023. This is down by 127 over the previous spring.
