# 8. Briefs, Submissions, or Recommendations from Elected or Appointed Representatives of Senate

8.1 Board Members Elected by Senate, Verbal Update

A. Russell and M. Smadu provided a brief update on the activities undertaken by the Board of Governors since the last meeting of Senate, which included the following:

At the December Board meeting, the Board approved:

- Investment-related items, including:
  - Replacement of an investment manager for the Pensions Plans Master Trust
  - Statements of Investment Policies and Goals for the University of Regina Pension Plans
  - o Statement of Investment Policies and Goals for the Trust and Endowment Fund
- The Provincial Auditor's Planning Memorandum for the 2023 audit
- Two faculty-based research centres
- Revisions to two policies Enterprise Risk Management, and Sexual Violence/Misconduct
- Collective bargaining agreement with the Administrative, Professional, and Technical (APT) employees
- Performance Management Framework Proposed Indicators for the third year of the 2020-2025 Strategic Plan
- Amendments to the Board Bylaws, and the 2023-2024 Board Meeting Schedule

At the December Board meeting, the Board also received an update on

Annual workforce demographics, and was given a strategic presentation on the Campus Master Plan.

In December, the Board also hosted the Distinguished Service Award dinner honouring Rob Kleisinger, former Manager of Mechanical Services

A half-day retreat was held in December that included a campus tour, including a tour of the ta-tawâw Student Centre, and an introduction to the consultants who will be leading the development of the Indigenous Engagement Strategic Plan. In January, a full-day facilitated retreat was held to reflect on accomplishments, discuss the current University environment and explore new ideas.

Two Board members' terms have expired: David Chow and Gary Bosgoed. The Lieutenant Governor will appointment new members by Order-in-Council. Chief Cadmus Delorme has agreed to assume the Vice-Chair position from Gary Bosgoed on an interim basis.

The Board will next meet on February 13<sup>th</sup> to provide input on the Indigenous Engagement Strategic Plan. Regular meetings of the Board are scheduled for March 7<sup>th</sup> and April 28<sup>th</sup>.

Following the report by the Board Members Elected by Senate, Senators were invited to ask questions. Discussion followed and included:

- Monitoring of the University's financial situation and oversight of the budget process by the Board of Governors
- The impact of the increase in remote learning on the budget

The President and Vice-Chancellor thanked M. Smadu and A. Russell for their report.

# 9. Administrative Reports

9.1 Winter 2023 In-Progress Report of Registrations, Appendix V, Pages 54-57

J. D'Arcy, Registrar, presented the report and highlighted the five-year enrolment trends, population segments, and the top nations for international recruitment.

Discussion followed. Topics of discussion included:

- It may be helpful for future reports to include the breakdown of remote vs. in person credit hours taught
- Some faculties and academic units provide a great deal of "service teaching" to students in other programs; a good example is La Cité universitaire francophone
- Confirmation that students registered through First Nations University of Canada and the other federated colleges are included in the figures presented, as all are University of Regina students

- Small variations in the reporting date for enrollment figures can occur due to meeting agenda deadlines
- New opportunities for international recruitment in areas such as Western Afria (Nigeria, Ghana, Sierra Leone), Vietnam and the Philippines
- Limitations on the number of remote courses that can be taken by international students, due to governmental restrictions

The President and Vice-Chancellor thanked J. D'Arcy for his report.
