COVID-19 Policies:

RDCs are Statistics Canada premises and must be compliant with the Government of Canada's policies and directives. Please remember, that while some provinces are starting to relax restrictions, RDCs follow the guidelines of The Public Health Agency of Canada, Health Canada and Occupational Health and Safety at Statistics Canada (OHS). Based on guidance from Health Canada, all researchers, staff, and visitors to the RDC must wear **medical grade masks** level ASTM1 or greater, this includes surgical masks and N95/KN95 masks but cloth masks will no longer be acceptable. NEW DATASETS IN THE RDC

CANADIAN ALCOHOL AND DRUGS SURVEY 2019

The main objectives of the **Canadian Alcohol and Drug Survey** (<u>CADS</u>) are to measure frequency of alcohol use, measure frequency of cannabis use, measure frequency of use of other drugs and measure potential harmful effects of alcohol, cannabis and other drugs. Up until 2017, Statistics Canada conducted the Canadian Tobacco, Alcohol and Drugs Survey (CTADS), which collected data on tobacco as well as alcohol and drugs. Starting with the collection of the 2019 Canadian Alcohol and Drugs Survey (CADS), content on alcohol and drugs has been collected on its own.

CANADIAN LEGAL PROBLEMS SURVEY 2021 New Survey

The purpose of the **Canadian Legal Problems Survey (CLPS)** is to identify the kinds of serious problems people face, how they attempt to resolve them, and how these experiences may impact their lives.

MEDICAL ASSISTANCE IN DYING 2019-2020 New Survey

The **Medical Assistance in Dying (MAID)** is based on reports from physicians and nurse practitioners on written requests for and cases of Medical Assistance in Dying (MAID) across Canada for the 2019 and 2020 calendar years.

MOTHER CENTRIC LINKAGES 1992-2019 New Survey

Through internal linkage in the Social Data Linkage Environment (SDLE), a cohort of mothers (Mothers File) was created using information from the Canadian Vital Statistics Birth Database (CVSB) and the Canadian Vital Statistics Stillbirth Database (CVSS). The Mothers File was then linked to data from the immigration, hospitalization.

SURVEY ON ACCESS TO HEALTH CARE AND PHARMACEUTICALS DURING THE PANDEMIC 2021 New Survey

The purpose of the **Survey on Access to Health care and Pharmaceuticals During the Pandemic (<u>SAHCPDP</u>)** is to better understand how health care service disruptions are affecting Canadians during the COVID-19 pandemic.

SURVEY ON ACCESSIBILITY IN FEDERAL SECTOR ORGANIZATIONS 2021 New Survey

The **Survey on Accessibility in Federal Sector Organizations** (<u>SAFSO</u>) will provide data for key indicators related to accessibility within the federal sector. These indicators will establish a baseline of accessibility in priority areas under the Accessible Canada Act.

UNIVERSITY AND COLLEGE ACADEMIC STAFF SYSTEM 1970-2010 New Survey

The **University and College Academic Staff System - Full-time Staff (<u>FT-UCASS</u>)** collects data on a wide range of socioeconomic characteristics that provide a detailed portrait of full-time university academic staff in Canadian universities. The data collected include gender, year of birth, principal subject taught, salary and administrative stipends, province or country of first and highest degrees earned, and academic rank.
