Once a student has been awarded the scholarship, they will continue to automatically receive the scholarship as long as they continue to be a student and continue to meet the eligibility criteria. Students who have not registered for two or more consecutive semesters will no longer be automatically assessed, and should they return to studies at the University of Regina, must apply for the scholarship again to reinstate the automatic assessment.
