The projected enrolment numbers seems ambitious. Two-year program will hopefully attract international students. Is this program sustainable? How often with CTHCH courses be offered? Currently these courses are multiple times a year; often enough that students will be able to complete the program within two years. With the majority of courses being CTCH courses, this program could be difficult for students to transfer in or out. Students will have multiple options to be involved with creative technologies such as completing a minor.

MOVED to create a Bachelor of Design Degree as outlined on pp. 17-18 of the Agenda, effective 202410.

It was noted that ACAD 100 and ENGL 110 are not equivalent courses. The Faculty is aware that those two courses are different. The assumption is students admitted to the program will already have ENGL 100 and so they can choose which course they can take similarly to the current MAP program templates. During discussion it was asked if additional faculty will be hired to teach the new courses. One additional faculty member will be hired to support this program, (current CTCH course instructors will also support). A couple of the new design courses, are essentially placeholders until an instructor is in place. Once new faculty hired, with their expertise, they will create additional courses in design.

There are resource implications for Faculty of Arts. Arts was not consulted about this program. Based on projected enrolments, Arts will have to add 2-3 additional courses with no resources; no instructors and 202410 is less than a year from now.

ED does not include the transfer credit in their after degrees. After degrees require a baccalaureate. This is different as it is a post-baccalaureate diploma.

In the information section about the program, credit hours should be revised from 60 to 120 credit hours so the template is not misleading.
