4.1. Registrar's Office

4.1.1. Experiential Learning and Community Service Designations Recognized as Institutional Honours

J. D'Arcy – M. Cappello

MOVED to have Experiential Learning and Community Service designations recognized as Institutional Honours at the University of Regina, **effective 202330**.

K. Bolen and V. McGuigan presented an overview of Experiential Learning and Community Service and why it is essential to include these designations on the parchment. Background information and rationale were included in Appendix A and B of the Agenda.

CESL met with stakeholders at all levels across campus. Students need recognition at the end of their degree. Some professors have already incorporated experiential learning and community service into their courses. Hours of experiential learning will be approved by the faculty. Hours of community service will be approved by CESL. These two designations will be a good addition to the current designations: Co-op, International, Internship, and Bilingual Mention. There will be rigour in the faculty-based content and reflection by the student. The typologies will help structure the regulations.

Thanks were given to the Registrar's Office for shepherding CESL through the approval process, and CCE was also acknowledged for helping with badge requirements.

During the discussion, the following points were made.

- How will this be implemented within Faculties?
 - User groups will be created across campus. It could be an instructor or administrative staff member.
- We want to capture all experiential learning across campus: e.g. classroom and assignments.
- We need to incentivize and validate the work the students are already doing. This aligns with the strategic plan to increase engagement thus, retention.
- This information will be captured through data collection and working with the student.
- There is a concern about increased workload within the faculties will the faculties be supported?
 - o CESL will help with reflections and goals.
 - There are two academic leads.
- If this designation is on parchments, there is concern that non-academics will be evaluating this designation.
 - The badges will be determined by non-academics. These requirements will be embedded within the courses.
- This evaluation model has been established in the Co-op office for the last thirty years.
- Serious consideration should be given to recognizing experiential learning as a separate type of recognition that is not on the parchment.
- Will the EL designation be attached to the course or CRN?
 - o The CRN.
- Nursing students are already in an experiential program. Nursing students will have to do
 additional requirements to receive the designation. The Nursing program is already intensive.
 Will this be fair?
 - We've developed typologies in consultation with areas across campus and external partners. Students will get EL in a variety of ways. We want well-rounded, careerready students.

- This designation will provide an incentive for student engagement.
- There is strong support for CESL's programming and services, but does experiential learning and community service need a parchment designation? The co-curricular transcript may be better suited. If it is already embedded in the degree, is there a need for a designation on the parchment? Is it necessary if all U of R students are known to have EL?
 - A designation will formalize the recognition.
- How will students be able to meet 500 hours of work on top of their regular workload?
- It'd be double counting if EL is already part of the course; it shouldn't be a designation.
- Is the effective date of 202320 viable?
 - The goal is long-term and a work in progress.

The Mover recommended that the motion be withdrawn for further consultation. Presenters agreed to seek further consultation.
