#### 3. Business Arising from the Minutes

#### 3.1. La Cité universitaire francophone

In June, the Committee agreed that the two new programs proposed by La Cité be forwarded to the Council Committee on Budget. CCB met on September 12, 2023, and the Chair, Dr. Monika Çule reported the following by email correspondence:

"[T]he application for creating the new programs indicates that there are no additional resources required to launch these programs. Since the CCB approval is only required for cases with new resource requirement[s], CCB did not entertain any formal Motion whether to support the creation of these program. We however, asked questions about the projected enrollments/revenues and flagged the projections in the Honours program as unrealistic. We advised the La Cité colleagues to correct the Honours program projections in the version presented back to CCUAS."

The Honours program projections have been updated in Appendix II, page 10 and 13.

Based on feedback from CCUAS, the new program templates have been updated to be in line with the Faculty of Arts new core requirements and the Honours program admission requirements have also been revised.

#### **Admission Requirements:**

Students must be accepted into the BA in French as a Second Language major before they can apply for admission into the Honours degree. Students may apply for the Honours degree once they have completed FRN 185 and FRN 285 with a minimum combined average of 75%.

#### Rationale:

It is not currently possible for a student to begin studying French and complete a BA in the span of four years. With the rise in demand for French-language programs throughout the world, and the end of several Core French programs in Canada, we aim to allow students to enter this program with no prior knowledge of French, and focus on communications skills throughout their degree.

This honours program is the same as the proposed BA FLS, with the addition of major GPA, PGPA and UGPA requirements for graduation and 9 credits in the major. It aims to allow students who hope to continue on to graduate studies or specialize through a dissertation to acquire an honours degree.

#### I. New Courses

#### FRN 185 (202430)

#### Initiation French Sec Lang (Initiation to French as a Second Language)

From the discovery to the acquisition of vocabulary and structures, this course will focus on building oral and written communication skills beyond the beginner level, while fostering cultural awareness of the Franco-phone world.

\*Note: Students may not receive credit for FRN 185 and any of FRN 100 or 101.\*

#### FRN 285 (202430)

#### Enrich français langue seconde (Enrichissement du français langue seconde)

From the acquisition of intermediate vocabulary and structures to their critical application, this course will focus on building oral and written communication skills toward bilingualism, while exploring issues within the Francophone world.

<sup>\*</sup>Note: No previous experience in French is expected for this course.\*

#### FRN 235 (202430)

#### Découverte linguistique franc (Découverte de la linguistique française)

Initiation au système de fonctionnement de la structure de base de la langue française.

\*\*\*Prerequisite: FRN 201, permission based on assessment test, or permission of Department Head\*\*\*

#### FRN 265 (202430)

#### Langue française littérature (Langue française et littérature)

Initiation à la littérature à partir de courtes œuvres ou d'extraits littéraires d'expression française.

\*\*\*Prerequisite: FRN 201, permission based on assessment test, or permission of the Department head.\*\*\*

#### FRN 302 (202430)

#### Perfectionnement du français (Perfectionnement du français)

Perfectionnement des compétences orales, écrites et culturelles.

\*\*\*Prerequisite: FRN 301 with a minimum grade of 60%, or permission of Department Head\*\*\*

#### FRN 462 (202430)

#### Littérature franco africaine (Littérature de la francophonie africaine)

Étude d'œuvres en langue française qui ont marqué l'histoire de la littérature de l'Afrique et de ses diasporas et qui explorent leur présent.

\*\*\*Prerequisite: FRN 366 with the completion of six credit hours at the FRN 300 Level or permission of Department Head\*\*\*

#### Justification:

Ces cours rendront possible la création d'un BA en FLS (voir motions 2022-10 et 2022-11) et ajouter davantage d'options pour les étudiantes qui désirent améliorer leurs compétences en français.

#### Rationale:

These courses will make it possible to create a BA in FSL (see motions above) and add further options for students hoping to better their French language skills.

<sup>\*\*\*</sup>Prerequisite: FRN 185 or FRN 200 (either with a minimum grade of 60%), or permission of Department Head\*\*\*

<sup>\*</sup>Note: Students may not normally receive credit for FRN 288 and FRN 200, 201, or 300.\*

#### FRN 371 (202410)

#### Colonialisme et réconciliation (Colonialisme et réconciliation)

Étude des institutions, structures et expériences propres au colonialisme canadien et des institutions et pratiques à même d'ouvrir des possibilités de réconciliation interpersonnelle, interculturelle, et entre nations. Le cours se penchera particulièrement sur les pensionnats autochtones et leurs effets, ainsi que sur les traités.

\*\*\*Prerequisite: FRN 301, Grade 12 French and permission based on assessment test, or permission of Department Head.\*\*\*

\*Note: students may only receive credit for one of FRN 371 and FRN 340AF.\*

#### FRN 461 (202410)

#### Littérature franco-canadienne (Littérature franco-canadienne)

Études des œuvres représentatives d'auteurs et autrices francophones du Québec et du Canada et en particulier de textes écrits en contexte minoritaire.

\*\*\*Prerequisite: FRN 366 with the completion of six credit hours at the FRN 300 Level or permission of Department Head\*\*\*

\*Note: students may only receive credit for one of FRN 461 or FRN 460AH.\*

#### Justification:

Ces deux cours régularisent des cours expérimentaux (AA-ZZ).

#### Rationale:

These two courses regularize experimental courses (AA-ZZ).

Colonialisme et réconciliation

#### Justification:

#### III. Course Revision

#### FRN 301 (202430)

#### Achievement II / Épanouissement II

This language and culture course will enhance writing skills and will further explore Francophone issues as well as provide a favourable environment for critical thinking. #### 4.1. Faculty of Arts

Item for Approval

The Faculty of Arts is submitting the following motion for approval to CCUAS:

#### 4.1.1 Revision to Psychology Honours Eligibility Requirements

**Motion:** To revise the Program GPA and Major GPA eligibility requirements to Psychology Honours program, **effective 202420**.

#### **BA Honours in Psychology**

The application process for the Psychology Honours Program is competitive, and admission into the program is not guaranteed.

Application to the Psychology Honours program requires the following:

- A minimum Program GPA of at least 70.00 80.00%;
- A minimum Major GPA of at least 75.00 80.00%;
- Completion of at least 60.0 credit hours;
- Completion of all Arts or Science Core Requirement courses (depending on whether registered in the BA or BSc program, respectively);
- Completion of the Honours Program Application Form (provided on the Department of Psychology website);
- A letter of intent (as described on the Department of Psychology website); and
- Unofficial copies of all undergraduate transcripts.

A student must have successfully completed 90 credit hours, all required PSYC 200-level courses, and Statistics in Psychology (PSYC 305) by August 31 prior to commencing the honours program.

Note that PSYC 405 must either precede or be taken concurrently with PSYC 400, and a minimum grade of 65% in PSYC 305 in needed to register in PSYC 405. Failure to meet these requirements will void the student's acceptance into the Psychology Honours Program, and the student will need to re-apply in a subsequent term.

Applications for the Psychology Honours Program must be submitted to the Department of Psychology by February 1 of the calendar year in which the student intends to enroll in the honours program. The application process for the Psychology Honours Program is competitive, and admission into the program is not guaranteed.

Refer to Graduation section for BA Honours graduation requirements and to the Faculty of Science section for BSc Honours graduation requirements.

#### Rationale:

Setting the Program and Major GPA to 80.00% will reduce the number of applications from students who would not be competitive for admission to graduate and professional programs.

#### PSYC 473 3:3-0

#### **Human Reasoning - Research**

Examines how people use, misuse, and fail to use available information in reasoning and decision-making with emphasis on theoretical, interdisciplinary approaches to understanding human reasoning and applications in everyday life. Discussion of contemporary issues will complement "hands-on" experience in designing and executing an empirical research study. \*\*\*Prerequisite: PSYC 270 and PSYC 305.\*\*\* \*Note: PSYC 220 is recommended.\* \*Note: This course will initially be restricted to PSYC majors. Non-majors will be eligible to register at a later point if space remains.\* \*Note: Students may only receive credit for one of PSYC 373 and PSYC 473.\*

#### **Human Reasoning**

Examines how people use, misuse, and fail to use available information in reasoning and decision-making with emphasis on theoretical, interdisciplinary approaches to understanding human reasoning and applications in everyday life. Discussion of contemporary issues will complement "hands-on" experience in designing and executing an empirical research study. \*\*\*Prerequisite: PSYC 204 and PSYC 270.\*\*\* \*Note: PSYC 220 is recommended.\* \*Note: This course will initially be restricted to PSYC majors. Non-majors will be eligible to register at a later point if space remains.\* \*Note: Student may only receive credit for one of PSYC 373 or PSYC 473.\*

#### 4.2.3 New Prior Learning and Recognition Policy

#### Prior Learning Assessment & Recognition (PLAR)

In consultation with appropriate members of Programs, the Faculty of Education may evaluate and grant credit for qualifying informal learning up to a maximum of 15 credit hours. Credit may be granted on a case-by-case basis and according to the Prior Learning Assessment & Recognition (PLAR) process. Credit will only be awarded for demonstrated learning which includes knowledge, skills and abilities. It will not be awarded for teaching experience alone.

Due to the requirements of the Saskatchewan Professional Teacher's Regulatory Board (STPRB) around Teacher Certification, the Faculty of Education will NOT consider PLAR for any field component (including internship and pre-internship as either stand alone or course embedded field) or courses specifically named by the SPTRB as certification requirements.

#### **Field Experience Components**

Education programs include extensive field experiences. Students should expect that at least some of these field experiences will be located in schools outside Regina. School divisions require students to have criminal record checks <u>and vulnerable sector checks</u> completed prior to participating in a school placement. Please be advised that students with a criminal code conviction that has not been expunged will face serious restrictions limiting where they can complete teacher education field requirements. <u>International students are also required to obtain co-op work permit to comply with Federal Government Regulations.</u>

#### **Accommodations for Field Components**

Students with documented disabilities and who are registered with Student Accessibility may be eligible for accommodations for required field components. Students requesting such accommodations should contact the Faculty of Education's Field Coordinator to begin the process of determining which accommodations may be possible. Such determination will occur in consultation with the accommodations officer in the school division of the pending field experience. Accommodations may vary as per both school division policies and degree requirements, and in keeping with the field requirements of the Saskatchewan Professional Teachers Regulatory Board. Determined accommodations will be documented by Student Accessibility and provided to the student's cooperating teacher and in-school administrator. This process seeks to provide fieldwork students with reasonable accommodations while ensuring that they fulfill the essential academic and program requirements of Field Experiences within the Faculty of Education.

#### **Repeating Internship**

If an intern withdraws or is required to withdraw from internship, a second attempt may be approved by the Director of Field Experience based on demonstration of readiness to repeat.

Students seeking to repeat a field component are required to meet with the Director and/or Coordinator of Field Experience to review issues identified in the Internship Placement Profile and to discuss next steps towards their continuation in the program.

Typically, a maximum of two attempts at internship will be allowed. However, a student who is unsuccessful twice at internship may appeal to the Professional Development Committee for a third attempt. The Committee serves as an advisory board to the Director. Interns whose placements are changed by the Director or Coordinator within a term will be considered to have attempted internship one time.

University Level Mandatory Fees

The following fees are mandatory for all University of Regina students:

- · student union fees;
- student health and dental insurance<sup>1</sup>;
- U-Pass (transit pass)<sup>2</sup>;
- academic technologies fee3; and
- recreation and athletic fee-4.
- · student services, health, and wellness fee4.

**Note 1**: The student health and dental plan is assessed in the fall term for students who register in a minimum of 9 credit hours at the undergraduate level or 6 credit hours at the graduate level. Students who register in less than the minimum number of 9 credit hours or register in the winter or spring/summer terms only must contact the University of Regina Students' Union to determine if they are eligible.

**Note 2**: The U-Pass is assessed to students who take at least one on-campus course, unless the student is eligible to opt-out. Opt-outs are managed by the University of Regina Students' Union (URSU). Some of URSU's opt-out eligible groups include: students who reside on campus; students who live outside the Regina city limits; and students on nursing practicums & education internships outside of Regina. Students should contact URSU for more information about eligibility, opt-outs, and obtaining a U-Pass when not automatically enrolled.

**Note 3**: The academic technologies fee is assessed to all students on and off campus (including Federated College students). The fee will not be assessed for on campus or off campus contract classes.

Note 4: The recreation and athletic fee is used to provide partial funding for fitness, wellness, recreation, intramural, and sport (e.g., Varsity Sport, Competitive Club Sport, Sport Clubs) related programming, services, and allows them to access facilities, activities, services, and programs at no cost or at a subsidized rate. This fee is mandatory even if the student does not access facilities, activities, services, programs, or related sport and recreation facilities on the University of Regina Main Campus. This fee is assessed to any student registered in courses scheduled as on campus.

Note 4: The student services, health, and wellness fee is charged to all students, regardless of location, as it provides partial funding for student services, wellness and recreation programming, online health resources, and fitness opportunities both remote and inperson, including programs such as:

- U of R Mental Wellness Hub
- UR Fit Online and On-Demand Programming
- Revive and Thrive Program
- U of R E-Sports

The fee also partially supports intramurals, athletic programs and in-person facilities at the Centre for Kinesiology & Health Studies, which includes funding student employment opportunities.

### II. RATIONALE (CCAM)

1. Describe the rationale/need for this program.

La Cité Universitaire francophone is more than an educational institution; it's a vibrant hub where Francophone culture, language, and growth converge. As the heart of French-language university programming, research, and services at the University of Regina and beyond, we are committed to fostering a diverse and inclusive environment that empowers both our students and employees.

We are dedicated to providing an environment that thrives on linguistic diversity, intercultural understanding, and personal development. Our mission is to support Saskatchewan's Francophones, regardless of their first language, and play an active role in their cultural, linguistic, and professional journey.

In response to the growing demand for comprehensive French-language programs worldwide and recognizing the decline of Core French programs in Saskatchewan, La Cité Universitaire francophone proposes the creation of a dynamic "Baccalauréat ès arts (BA) – Majeure en français langue seconde (FLS)" program. This program will enable students to achieve linguistic proficiency, cultural competence, and a deep understanding of Francophone contexts within a four-year timeframe. The demand for such an immersive and integrated program is evident, positioning La Cité as a leader in addressing the educational needs of Saskatchewan's Francophones and promoting French language and culture. It outlines a comprehensive approach to meet the

educational needs of Saskatchewan's Francophones, bolstering linguistic proficiency, cultural competence, and experiential learning within a cohesive program framework.

2. What are the key objectives and/or goals of this program and how will it be delivered?

The program's key objectives are as follows:

- Attainment of B2 or C1 proficiency level on CEFR French tests.
- Acquisition of practical language skills for effective communication in a Francophone environment.
- Exploration of diverse Francophone cultures and histories, fostering cultural competence.

To achieve these objectives, the program integrates grammar, writing, and speaking skills throughout the curriculum. We propose the development of specialized concentrations within the program to cater to a variety of student interests and career paths.

Delivery:

The program will be offered in person, at the University of Regina.

3. How does this program compare to similar programs (Provincial/National)?

Rather than separate grammar, writing, and speaking, this program mixes all three to focus on students' competencies and ease of speaking. In this, it follows the model of our Certificate in French as a Second Language, without duplicating it. Only later on in the program do we offer courses to work specifically on writing or speaking, for those students who need those skills.

Whereas many French as a Second Language programs offer language and literature courses and introductory linguistics, this course pushes student toward more linguistics courses as well as courses on culture and history, so as to aim for a greater degree of explicit cultural competency.

4. List the expected benefits of the program to University of Regina students.

It will be possible to recruit students directly into this program, which is not currently possible with our major and certificate options, and only with our minor, which cannot be completed in an immersive or intensive setting.

It will also lead to more courses in French being offered and available to all students. This includes entry-level linguistics (FRN 235) and literature courses (FRN 265), which will benefit those who have gone through immersion and hope to keep up or strengthen

their French, and an upper-level language course (FRN 302). Beyond these three courses, we expect to be able to offer at least an additional two courses in French per year as electives, for a total of five.

In addition, it will be possible for students who have completed the Certificate in French as a Second Language to integrate this new BA, based on an expected level for entry into the BA, and an individual assessment test.

5. What is the impact on current programs? Does this program duplicate or overlap with existing University programming in any way? If so, the affected unit(s) must be consulted. Attach letters from affected units that show the host unit(s) and affected unit(s) have established a plan for managing the program overlap.

This program does not duplicate or overlap other existing programs.

This new program will bring more students into the upper-level courses already taught at La Cité, including the African Studies courses (EAS). It will also enable us to offer more courses in French (5), thus broadening our capacity to meet the needs of the Francophone and specifically Fransaskois community.

While our Certificate in French as a Second Language aims to bring students to an intermediate level, the new BA (FSL) program aims for fluency as well as cultural competency.

It is also expected that many students will want to continue to our Master's program in French and Francophone Intercultural Studies, since an MA is a qualifying degree for teaching in many countries.

### III. STRATEGIC CONSIDERATIONS (CCAM)

1. How does this program support your Faculty's Strategic Plan?

Recruitment and Student Success: La Cité will strategically target high-school graduates mainly from international countries (e.i. Nigeria, Ghana) and from Saskatchewan Core-French and French Immersion programs, positioning itself as the preferred destination for quality French-language post-secondary education. Student success will be supported through a comprehensive suite of services offered by the Center for Student Services, including scholarships, tutoring, academic advising, and career counseling. Expanding these services to include workshops, screening, and resources for student well-being will enhance retention rates.

- 1) Answer educational needs in French in SK as French is left aside in high schools, this opens a new possibility to learn the language;
- 2) Contribute to bilingual life in SK create a program for students who will become bilingual;
- 3) Recruitment higher number of registrations and more possibilities to learn;
- 4) Programs of study widen the range of programs in French.

These interdisciplinary initiatives contribute not only to program diversification but also to the vitality of the Fransaskois community by producing bilingual graduates in critical areas of law, health care, and social services.

This program also ties directly into internationalization through targeted recruitment of students from la Francophonie (area of focus #1). It also promotes institutional identity by enhancing La Cité's contact with la Francophonie (area of focus #5). In addition, during their studies the social impact of a greater number of students in Frenchlanguage programs will be significant on Francophone communities as the graduates enter the workforce and settle in the community (area of focus #5).

3. Are there any other strategic considerations for this program?

This program aims to use to its full capacity the existing faculty complement at La Cité and allow for future growth, notably by adding concentrations once it becomes possible to offer more courses.

4. Does this program support external and/or community needs? Please attach letters of support if available.

As this program will also aim to recruit international students, it becomes a part of the Francophone immigration effort. By having well-rounded students, we will also provide additional French-speaking workers to the Saskatchewan and federal civil service, the private sector, which is a need that the Fransaskois community continues to express.

Building on La Cité's commitment to experiential learning, the program will expand its Co-op opportunities and establish partnerships with the Fransaskois community. These partnerships will link in-class learning to real-world experiences, enriching students' cultural immersion and practical language application. This approach not only enhances student engagement but also strengthens ties between the university and the community.

### II. RATIONALE (CCAM)

1. Describe the rationale/need for this program.

La Cité Universitaire francophone is more than an educational institution; it's a vibrant hub where Francophone culture, language, and growth converge. As the heart of French-language university programming, research, and services at the University of Regina and beyond, we are committed to fostering a diverse and inclusive environment that empowers both our students and employees.

We are dedicated to providing an environment that thrives on linguistic diversity, intercultural understanding, and personal development. Our mission is to support Saskatchewan's Francophones, regardless of their first language, and play an active role in their cultural, linguistic, and professional journey.

In response to the growing demand for comprehensive French-language programs worldwide and recognizing the decline of Core French programs in Saskatchewan, La Cité Universitaire francophone proposes the creation of a dynamic "Baccalauréat ès arts (BA) – Majeure en français langue seconde (FLS)" program. This program will enable students to achieve linguistic proficiency, cultural competence, and a deep understanding of Francophone contexts within a four-year timeframe. The demand for such an immersive and integrated program is evident, positioning La Cité as a leader

in addressing the educational needs of Saskatchewan's Francophones and promoting French language and culture. It outlines a comprehensive approach to meet the

This honours program is the same as the proposed BA FLS, with the addition of major GPA, PGPA and UGPA requirements for graduation and 9 credits in the major. It aims to allow students who hope to continue on to graduate studies or specialize through a dissertation to acquire a honours degree.

2. What are the key objectives and/or goals of this program and how will it be delivered?

The program's key objectives are as follows:

- Attainment of B2 or C1 proficiency level on CEFR French tests.
- Acquisition of practical language skills for effective communication in a Francophone environment.
- Exploration of diverse Francophone cultures and histories, fostering cultural competence.

To achieve these objectives, the program integrates grammar, writing, and speaking skills throughout the curriculum. We propose the development of specialized concentrations within the program to cater to a variety of student interests and career paths.

Delivery:

The program will be offered in person, at the University of Regina.

3. How does this program compare to similar programs (Provincial/National)?

Rather than separate grammar, writing, and speaking, this program mixes all three to focus on students' competencies and ease of speaking. In this, it follows the model of our Certificate in French as a Second Language, without duplicating it. Only later on in the program do we offer courses to work specifically on writing or speaking, for those students who need those skills.

Whereas many French as a Second Language programs offer language and literature courses and introductory linguistics, this course pushes student toward more linguistics courses as well as courses on culture and history, so as to aim for a greater degree of explicit cultural competency.

4. List the expected benefits of the program to University of Regina students.

It will be possible to recruit students directly into this program, which is not currently possible with our major and certificate options, and only with our minor, which cannot be completed in an immersive or intensive setting.

It will also lead to more courses in French being offered and available to all students. This includes entry-level linguistics (FRN 235) and literature courses (FRN 265), which will benefit those who have gone through immersion and hope to keep up or strengthen their French, and an upper-level language course (FRN 302). Beyond these three courses, we expect to be able to offer at least an additional two courses in French per year as electives, for a total of five.

In addition, it will be possible for students who have completed the Certificate in French as a Second Language to integrate this new BA, based on an expected level for entry into the BA, and an individual assessment test.

5. What is the impact on current programs? Does this program duplicate or overlap with existing University programming in any way? If so, the affected unit(s) must be consulted. This program does not duplicate or overlap other existing programs.

This new program will bring more students into the upper-level courses already taught at La Cité, including the African Studies courses (EAS). It will also enable us to offer more courses in French (5), thus broadening our capacity to meet the needs of the Francophone and specifically Fransaskois community.

While our Certificate in French as a Second Language aims to bring students to an intermediate level, the new BA (FSL) program aims for fluency as well as cultural competency.

It is also expected that many students will want to continue to our Master's program in French and Francophone Intercultural Studies, since an MA is a qualifying degree for teaching in many countries.

### III. STRATEGIC CONSIDERATIONS (CCAM)

Recruitment and Student Success: La Cité will strategically target high-school graduates mainly from international countries (e.i. Student success will be supported through a comprehensive suite of services offered by the Center for Student Services, including scholarships, tutoring, academic advising, and career counseling. As this program will also aim to recruit international students, it becomes a part of the Francophone immigration effort. By having well-rounded students, we will also provide additional French-speaking workers to the Saskatchewan and federal civil service, the private sector, which is a need that the Fransaskois community continues to express.

Building on La Cité's commitment to experiential learning, the program will expand its Co-op opportunities and establish partnerships with the Fransaskois community. These partnerships will link in-class learning to real-world experiences, enriching students' cultural immersion and practical language application. This approach not only enhances student engagement but also strengthens ties between the university and the community.
