- Guidance for the verification of Indigenous identity will be shared with those in hiring positions when finalized
- Recruitment strategy for domestic students and opportunities to learn more about why students select the University of Regina as their chosen institution
- Status of searches for vacant Dean positions

The Provost and Vice-President Academic provided a brief presentation on out-of-scope salary spending at the University compared to academic salaries for the last three years.

Discussion followed and included:

- Comparison of the University of Regina proportionate spend to other Canadian universities

The Provost and Vice-President provided information regarding the intention to create an advisory group/committee to explore structural changes at the University of Regina that could result in long-lasting cost savings. Discussion followed with respect to its membership composition.
